Sir,

In producing herewith one arrested accused person namely Md. Kaleem (33) S/O Lt. Abdul Kureshi of Kholaibhaktari, PO+PS-Matigara, Dist-Darjeeling under arrest along with seized cattle and vehicle as per seizure list.

1] Three numbers of cattle along with two calves inside the hood of the Vehicle bearing Registration No- BR-06-GF-4785.

2] One (01) Bolero Pick-up Vehicle of Mahindra Company bearing Registration No- BR-06-GF-4785.

I, SI Agen Lepcha of Matigara Police Station under Siliguri Police Commissionerate do hereby lodged a written complaint against one arrested accused person named Md. Kalim (33) S/O Lt. Abdul Kureshi of Kholaibhaktari, PO+PS-Matigara, Dist-Darjeeling to the effect that today on 19.07.2023 at 02:15 hrs received a specific source input that huge numbers of stolen cattles are being transported to Jalpaiguri in one Boler Pickup vehicle bearing Registration No. BR-06-GF-4785 through Matigara Patiramjote Road. Accordingly the fact was informed to O/C Matigara PS and diarized the matter vide Matigara PS GD Entry No- 909, Date 19/07/2023 and as per direction of O/C Matigara PS I, along with SI Sajal Roy, SI Sailesh Subba, C/974 Mintu Sen and CVF/977 Ganesh Paswan left for Patiramjote under Matigara P.S. to verify the veracity of the source information. At around 02:30 hours we reached at Patiramjote area and started waiting for the said vehicle to arrive at spot. At about 02:45 hours we saw one pickup vehicle approaching towards us from a considerable distance. Accordingly we prepared ourselves and intercepted the vehicle bearing Registration No- BR-06-GF-4785 and found driver inside the vehicle. Accordingly I disclosed our identities as Police Officer to him and after checking the vehicle we found five numbers of cattles loaded in the vehicle. On demand the accused driver could not produce any valid documents or any satisfactory answer for transporting the loaded cattles. He also failed to produce any documents in respect of the cattles and said vehicle. Hence there was a strong reason to believe that the above noted accused driver has procured the cattles by illegal means and transporting the same dishonestly for his illegal gain.

During further interrogation the accused driver disclosed his name and identity as noted above and confessed his guilt and stated that he received the loaded cattles from elsewhere clandestinely for his wrongful and illegal gain. He further stated that he was going to deliver the said cattles to Assam border area. Accordingly I seized (05) five numbers of cattles in different colour and sized and one vehicle bearing Reg. No. BR-06-GF-4785 in presence of witnesses as per proper seizure list. The seizure was made in between 02:55 hrs to 03:10 Hrs. Thereafter I arrested him after observing all sorts of formalities.

I, therefore pray before your honour that a specific case may kindly be started against the arrested accused person Md. Kaleem (33) S/O Lt. Abdul Kureshi of Kholaihbaktari, PO+PS-Matigara, Dist-Darjeeling and the owner of the vehicle as per proper section of law.
