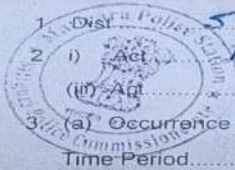

Dear Sir,

With due respect I the undersigned would like to inform you that, on and from the month of October, 2016 I was appointed by Chief Inspector Food & Supplies Matigara Block for the post of Data Entry Operator on temporary basis and during the said period of job, the Secretary of Uttarbanga Rural Development Organization, Belakoba, P.S Rajganj, Dist. Jalpaiguri issued a temporary appointment letter vide Ref No. URDO/02-21/AL-DEO/94 dated 04.02.2021 to me for the same post at Food & Supplies Matigara Block, Shivmandir, P.S Matigara, Dist. Darjeeling w.e.f. 05.02.2021 against the monthly salary of a sum of Rs. 13,000/- and other benefits.

I would like to further inform you that, after the said appointment as stated above, Sri Dipankar Kumar Roy, Food Inspector has provided me the official ID and Password and he directed me to make the huge number of data entries of the ration card holder without any support of documents and he has also directed me to enter the data entry of the name of huge numbers of undistributed ration cards of tea garden area on the account of the Ration Dealership being M.R No. 84 belonging to Sri Bimal Chandra Roy, S/o. Late Chhirmohan Roy of Choto Dhukuria Jote, P.O New Chamta, P.S Matigara, Dist. Darjeeling and other 41 numbers of M.R Shops stand in the name of the family members and other relatives of said Bimal Chandra Roy. During the said work since 2016, I came to know that in the year of 2020, Sri Shaswata Sundar Das who was The District Controller Food and Supplier, Siliguri has allotted 83,018 numbers of temporary coupons which were issued by B.D.O Matigara Block in connivance with said Bimal Chandra Roy and same were distributed by Smt. Dayanti Roy, W/o. Said Bimal Chandra Roy through the ration shop being M.R No. 84, 87, 07, and 92 during the period of Covid-19 pandemic. I also came to know that within the Tea Garden area, Matigara Block there are hardly 15,000 ration card holders under ten numbers of non workers ration shops but said Bimal Chandra Roy in connivance with the officials of Food and Supplies department falsely prepared 49,045 ration cards in the place of original 15,000 ration card holders.

I would like to further inform you that, when said Bimal Chandra Roy and officials of said Food Supply department realized that I have the above mentioned information regarding their illegal act and activities and they cannot take me in their said illegal act and mission, on 25.02.2021 I was thrown out from my said service without any reasonable cause and due to my protest of the said illegal termination, my employer has misbehaved with me including the threatening to implicate me in false criminal case and in spite of several representation and complaint as made by me to the various authorities, I did not get any justice. And for ventilation of my grievance I went for hunger strike on and from 20.05.2021 for 16 (sixteen) days and out of the assurance of Matigara police station regarding the justice I withdrawn the said hunger strike on

06.06.2021 but it was very unfortunate that I have been implicated in a criminal case being Matigara P.S Case No. 673/2022 dated 09.06.2022, under section 342, 186, 353 of I.P.C.

I would like to further inform you that, I was compelled to file a Writ Application being W.P.A No. 2125 of 2022 before Hon'ble High Court at Calcutta, Circuit Bench at Jalpaiguri against the officials of food supply department and said Bimal Chandra Roy and others challenging the said termination of my job and against the police inaction in respect of my specific complaint and allegations but the said prayer was rejected by the Hon'ble Court on 31.10.2022 and against the said order dated I have filed an appeal being Mat No. 94 of 2022. During pendency of the said appeal I have filed an application for stay being CAN No. 1 of 2023 on 07.07.2023.

It should be mentioned here very recent I came to know said Bimal Chandra Roy has been trying to install a crasher at river side in the locality and said act is found illegal and some news has been reported in the News Paper and for that Mr. Roy has made a press meet and I made a comment via facebook.

I would like to further inform you that, after receiving the copy of the said notice from the Hon'ble Court, said Bimal Chandra Roy made a nasty plan to harass me and compel me to withdraw the allegations before the court of law and for that as per his instruction one of his men namely Sanjay Singha @ Kechra came to me and started to abuse filthy languages to Mr. Roy with a plea that Mr. Roy has also thrown out him from the job as provided by Mr. Roy on the same fashion as like I was thrown out from my service for taking me in his confidence and he somehow managed to bring me in a restaurant and offered me some cold-drinks and after consuming the same I understood that said Sanjay Singha @ Kechra has mixed up something with the said drink and I started to feel drowsy and taking that advantage as per his arrangement, he has managed to take some photographs of me with an unknown girl and when I protested the same he has started to quarrel with me. On 15.07.2023 in the morning at about 7 a.m. said Bimal Chandra Roy, his nephew Mithun Saibo came to my place in a four wheeler (Bolero) and the driver of the said vehicle and said Mr. Roy threatened me to go with him and somehow he has forcibly brought me in his house and after reaching there, said Mr. Roy snatched my mobile phone (Samsung A32, 6/128 GB Black) being IMEI No. 353089185478746 having cell no. 97326-36523 from me and took me inside a hall and I found there his wife Smt. Dayanti Roy, Sanjay Singha @ Kechra, Jogesh Roy, Biswanath Singha, Bipul Roy, Tapan Roy, Manoj Kumar Singha, Sanjit Kumar Singha, Mithun Munda, Atul Singha, Smt. Roma Saibo and others unknown to me. Thereafter said Mr. Roy called my father and after reaching my father there, said Mr. Roy also snatched the mobile phone of my father and he started to abuse filthy languages to us and told me that if I will not withdraw my allegation as made before the court of law, he will give me a lesson and directed me to put it in writing regarding the said withdraw of allegation and on refusal he and his associates started to assault me by fist and blow and I sustained blood injury in my left ear and lower lip and whole day they confined me and my father in the said place and tortured upon me and my father for obtaining the said declaration of withdraw of allegation. Due to the continues torture including physical assault and

threatening of killing me and father and for saving the life of my father at last I gave the consent to put my signature in some documents which have been prepared by said Mr. Roy and as per his threatening and instruction I was compelled to put my signature in those documents and Mr. Roy has also taken my thumb impression in those documents and the entire event of said signature was made video in the mobile of Mr. Roy and his associates by saying that for future reference and they have also compelled me to say orally that I have subscribed my hands in those documents voluntarily and I have no further allegation against Mr. Roy and his family members and also compelled me to say that I invoked the jurisdiction of Court of Law for blackmailing him and lower down his prestige in the society and after obtaining my signature and thumb impressions in all those documents, Biswanath Singha took the photographs of those signed documents and made pdf and send it to my mobile phone and in my presence he started to sent and forward to the various persons and department and authorities including my advocate as if myself is sending those photographs to them from my mobile phone. Apart from that Mr. Roy has also obtained my signature and thumb impression in some documents relating to the 'no-objection' for installation of crasher at river side in the locality. Thereafter at about 10 p.m. at night said Mr. Roy and his associates released me and my father from there illegal custody keeping my mobile phone in the custody of Mr. Roy and before releasing Mr. Roy and his associates again threatened me that if I will try to take any legal action against him and his family members, he will not hesitate to kill me and family members.

I would like to further inform you that, after getting the release from the illegal custody of Mr. Roy and his associates, I alongwith my father somehow saved our life and became very shocked and after reaching the house I couldn't sleep and my health condition became very poor and yesterday I thought everything in every aspect regarding my future and my family members and at last I have decided that I will not leave my legal battle for the justice.

Under the above circumstance, I would like to request you to investigate the matter and do needful for the ends of justice.
