Subject: - FIR

Sir,

With due respect, I SI Krishna Ch. Mandal of Matigara P.S SPC would like to lodge this written complaint against Subash Mandal, Sourav Sarkar and 20/25 others members of Bharatiya Janata Party to the effect that today i.e 21.07.2023 at 09:05 hrs myself along with other officers, Lady officer, force, lady force left PS for BDO Office, Matigara vide MTG PS MCC No.240/23 Dtd-21.07.2023 for L/O duty in c/w protest demonstration by members of Bharatiya Janata Party before the Block Development Officer Matigara. This refers to Matigara PS GDE No.1028 Dtd- 21.07.2023. Here to note that 144 Cr.P.C was promulgated within the 100 mtrs of the office of BDO Matigara on 21.07.2023 from 08:00 hrs to 18:00 hrs for prevention of breach and peace within the area.

At around 13:00 hrs 20/25 members of Bharatiya Janata Party under the leadership of above noted persons assembled there unlawfully and started protest demonstration in front of BDO Matigara Office. At that time they were informed regarding the above noted order of 144 Cr.P.C. But all of sudden they became furious and unruly and tried to enter the BDO office premises forcefully. At that time being resisted, they became more violent and demolished one guardrail installed there for the purpose of L/O duty and also restrained the Police personnel from discharging their lawful duty at the spot.

Under the above circumstances, I pray before your good office that a specific case under proper section of law may kindly be initiated against Subash Mandal, Sourav Sarkar and 20/25 others members of Bharatiya Janata Party and arrange for its investigation.
