Respected Sir/Madam,

With the respect I Ramesh Jaiswal wife of Tapas Jaiswal residing at Indrapally, Shivmandir, at my elder brother house I got married to Tapas Jaiswal s/o Bidyut Jaiswal a resident of Nepalipatty, Gainganagar, Ward No. 1, Siliguri on 06.12.2020 at Siliguri Katwarbyahat Bazar, Durban Road, Siliguri. At the time of agreement for the finalization of marriage, Tapas Jaiswal along with his father and mother demanded Rs.10 lakh cash, gold ornaments of 6 tola (72 gram) with a bride, king size wooden bed, almshub, sofa set, refrigerator, dressing table, groom sherwani and 4 tola (48 gram) gold chain and gold ring for groom to which my father agreed after a lot of discussion and assurances from them that they will provide all the benefits to me only since Tapas Jaiswal was working in Siliguri Municipal Corporation and had multiple registered land and ultimately it is me who is going to gain all the benefits, thus my father agreed to all of their demand thinking that I will stay happily after marriage. Just one week before the date of marriage Tapas Jaiswal demanded LED TV and Titan Wrist Watch to be given to him during the reception party to which my father agreed since the marriage card was already distributed among the relatives. My dad also transferred Rs.3 lakh in Tapas Jaiswal Bank account before the marriage when they insisted for it. After the marriage as per their demand cash and items stated above was delivered at my in law's house but unfortunately, King size bed was not fitted in my single room after which Tapas Jaiswal demanded to ask my parents to change the wooden king-size bed to a bit smaller one which cost Rs.58000. When I denied, he started abusing me using filthy language after which I started crying but all in vain. They did not allow me to use mobile phone and threatened me that I will not be allowed to speak to my parents and have to sleep on the floor till my parents give them a smaller king size bed. They forced me to sleep on the floor and both Tapas Jaiswal and his mom-dad used dirty language regularly after which I had to ask my parents to replace the bed which took more than a month and till it was delivered to my home I sleep on the floor only. It was a daily affair for them to use foul language and curse my parents for not giving them enough money, they only wanted money from my parents and brother. Tapas Jaiswal use to locked me inside a single small room while going for duty in the Siliguri Municipal Corporation and I was not allowed to step outside the room even in his presence. He used to block my parents and brother contact number so

that they couldn't contact me mentally torturing both of us. He knew that my mom-dad had high blood pressure with dad having diabetes, still he never allowed me to go to my parents house neither he allowed my parents to visit

our home and speak to them. I always used to cry and beg before him and his parents but they never listened to me rather Tapas Jaiswal used to threaten me that he will divorce me and marry someone else if I do not fulfill their demand. Meanwhile, I got pregnant, and I expected that things will change, but to my utter surprise they started abusing me and threatening me demanding more money from my parents and elder brother Pintu Prasad Jaiswal who was working as an Assistant Professor at Kalipada Ghosh Tarai Mahavidyalaya, Bagdogra.

At the time of delivery, my husband Tapas Jaiswal took over all the ornaments given to me by my parents including those kept in the locker and handed them over to his mom Manju Jaiswal. On 9th October, 2021 I was admitted at Siliguri Civil Hospital, Venus More where I gave birth to a baby girl through normal delivery. Hearing about the birth of the baby girl Tapas Jaiswal used foul language against me and left me in the hospital and ran away to his home. None of his parents visited me at the hospital just because I gave a birth to a baby girl while they were expecting a boy.

After 3 days, my parents got me discharged and we went to my husband house but they did not allow me to enter their house rather they abused me and my parents in front of the entire people. I kept begging and crying inconsolably to allow me and my baby girl to enter the house but he demanded money and threatened me that he will send the baby to an Orphan-House (Annath Ashram) and will kill me and nothing will happen to him. He knows a lot of influential people in the Siliguri Municipal Corporation.

After struggling for 4 hours in the hot and humid weather outside their house I had to return to Shivmandir along with my parents when they did not allow me to enter the house and to date, I am staying with my elder brother in Shivmandir. During this period, I even went to the Mahilasamaj of Kalwar Byahut Bhavan, Burdwan, where the marriage had occurred, but still, nothing happened, we even contacted the local people of Ganganagar to help me, but all in vain. Last week, I tried to get inside their house, but they did not allow me to enter and demanded Rs. 10 lakh cash, when I objected, he threatened me that he will kill me and my baby if I do not bring Rs. 10 lakh cash.

Sir, I am in danger and I need legal help for myself and my 20-month-old baby. Please help.
