my uncle who is the pujari (Pardit) of the said temple
tried to stop her from making the video within the temple
premises as it is a holy place.

That then after she started abusing my uncle namely
Sri Suresh Balmiki who is the pujari (Pardit) of the temple.
That after some time she again came to the temple with
her sons and other local boys and she threatened my
uncle by saying that she will make videos and will
create nuisance in the temple and she said to my uncle
that he has no right stop her from doing this act
inside the temple.

And as she is a woman she also threatened my
uncle that she will implicate my uncle in a false case.
That yesterday on dated 19/7/23 almost around 9:00 PM
at night when I was cleaning the temple then suddenly
she entered the temple premises with her sons and
other local boys and started shouting at temple premises
and when I heard her voice I came out from the temple
and tried to stop them.

That thereafter suddenly smt Amrita Balmiki started
abusing me and other boys who were with her
previously her son grabbed my shirt collar and started
slapping me and thereafter I started loudly then
after my uncle and my brother came and they
tried to save me from the boys who were slapping me.
But they didn't stop and started hitting my
uncle my brother and my mother (namely - Jali
Balmiki) and due to which my mother suffered a serious
injury in her chest due to which currently she is
admitted at Si liguri Dist hospital.
And due to the serious injury on the chest of my mother
she is facing breathing problem and at the same time
we were also injured during this incident.

So, sir I kindly request you to take strict and
necessary legal action against those above named
persons.
