Sub: - Written complaint against 01(one) TOTO Driver plying illegally at Kachari Road (Near Hospital More) without any valid documents causing obstruction to public way.

Sir,

I ASI Rajat Kr. Saha of Panitanki Traffic Guard, SPC beg to lodge a written complaint that on 22.07.23 around 13.35 hrs, while on duty at Hospital More found one (1) TOTO without any registration number stationed near Kachari Road, Hospital More in such a way blocking the free flow of traffic and causing hindrance and danger to the general public and other vehicles.

Accordingly I detained the said TOTO and on being asked the driver disclosed his identity as Sanjay Das (22 yrs), S/O Sukumar Das of Jalpaimore, Shitala Para, Saktigar, NJP. Further on being asked to produce relevant document in support of their claim of plying TOTO on Major Road they failed to produce the same. Thereafter I seized the said TOTO and arrested the said person under section 41 Cr. PC in c/w the case after observing all rules and formalities.

Therefore I would request you to kindly start a specific case against the above noted person (TOTO Driver) under proper section of law from your end.
