I, Soumyadeep Ganguly, S/O Sri Sibnath Ganguly presently posted as Divisional Engineer (Tech) in Siliguri Town Division, would like to inform you that today on 22.07.2023 during site inspection at about 7:00 am by the HT Mobile Van Personnel of Subhaspally 33/11kV substation under the jurisdiction of this office, it has been discovered that above mentioned materials have been stolen from a Distribution Transformer Structure of Treasury Office near Court More, Siliguri by unknown persons. This theft has lead to a prolonged interruption in the Treasury Office, a high value LT Bulk consumer of Siliguri Town Division.


You are therefore requested to kindly treat this as an FIR and investigate the theft of materials against section 136 (1) (a) and section 140 of Indian Electricity Act 2003 duly amended in 2007.
