This is to inform you that I Anmol Agarwal I/O Binod Kumar Agarwal, Ghanson of Hanuman Das Agarwal resident of Vidyapar Road, Khalpara Ward no. 7, a theft had occurred on 21st July 2023, midnight around 1am at our Godown in Nitya Building 1st Floor in Galry, Naya Bazar Siliguri. Our former I Agarwal Trading Co.

The thieves climbed through the window and cut the grill of the window, broke in and stole the following goods

3 carton NOVA DIET LITEE (1 LTR x 105 pcs) + (1/2 LTR x 60 pcs) total 135 LTR water ₹ 72900.

1 BAG BLACK PEPPER (30 kg) worth ₹ 21000.

Total worth of Goods being ₹ 93900.

We got to know about the incident when we opened our Godown in the morning @ 10 am. We also found black pepper and NOVA LITEE fallen roadside.

Later in the afternoon the local guard (Chokidar) informed that he had heard noises and has seen the thieves.
