Today, things escalated when my wife was doing her household work. Mrs. Chandana Singha Roy started using obscene language targeted towards her. Things escalated when she attacked me with an umbrella, threw a shoe towards my daughter, even took a spade while attempting to attack her.

She also slandered my daughter 21-year old daughter, accusing her of sleeping with multiple men while she was doing her Bachelors.

She also threatened to vandalize my cars which remain parked at our yard.

It has been difficult for my family and me to survive through these mental harassment episodes. I'd like to request you to kindly look into the matter and take necessary steps to ensure our security. Thanking you in anticipation.
