Sub: Complaint against my son **SRI BISWARUP GHOSH** and Daughter-In-Law **SMT. RINKI GHOSH** for committing mental torture, misbehavior, ill treatment, threatening upon me and my married daughters.

Respected Sir,

With due respect, I, **SMT INDRANI @ PAPIYA GHOSH**, Wife of Late Bidhan Chandra Ghosh, Permanently residing at Hill Cart Road, Near Hotel Vinayak, Ward No. VI of Siliguri Municipal Corporation, P.O. & P.S Siliguri, Dist-Darjeeling, would like to ventilate some painful facts for your kind perusal and also for taking appropriate steps:-

1. That Bidhan Chandra Ghosh (Since Deceased) was my legally married husband and out of our wed-lock, one son and two daughters were born and their names are (1) Sri Biswarup Ghosh (2) Smt Madhumita Ghosh Gurung (3) Smt Moumita Roy respectively and all my son and daughters are married. My daughters are living with their respective husbands at their respective matrimonial houses.
2. That we have arranged the marriage of our only son Sri Biswarup Ghosh with the daughter of Sri Sunil Ghosh of Katihar, Bihar namely Smt Rinki Ghosh and their marriage was solemnized on 19.11.2013 as per the provisions of Hindu Rites & Custom after observing all formalities and a reception ceremony was also performed according to our financial stability.
3. That after the marriage of my said son, I, along with my deceased husband, our son and daughter-in-law have started to reside in a joint family and we used to give our full support, love and affection to our said son and his wife i.e. my daughter-in-law. It is very painful to mention here that we became surprised about the abnormal attitude and behaviour which we received from the side of our son and his wife and this thing started to happen just after elapse of one month of their marriage. They started to neglect us in every manner and they did not bother to give respect and honor to me and my deceased husband.
4. That Sir, I am aged about 67 years and naturally at the stage of my old age, I expected that I will receive love and affection from the side of our son and daughter-in-law but in fact, just after one month of their marriage, my son and my daughter-in-law have clearly stated their views by showing their different attitude and behaviour that they are not willing to take any responsibility towards the health, food and maintenance of myself and my deceased husband. We being the parents, have always tried to understand them at least to behave properly with us at the stage of our old age, but they did not pay any heed to our request and on contrary the momentum of torture has been increasing day by day by them to us. We did not make any protest even after receiving such type of mental cruelty and torture from our

said son and daughter-in-law and we were presuming that after lapse of time, our son and daughter-in-law will definitely realize their own mistake but our presumption was wrong and only after one year of marriage of my said son, they have started to live separately in the premises of my deceased husband and they did not take any care upon us and on contrary, they started to inflict mental torture upon us and day by day, the same was increased by them.

5. That during the lifetime of my husband, he had constructed a dwelling house of four storied building on the land measuring 0.03 acre out of his hardest money and for the safety of our future, we have let out some shop rooms to the different tenants. Prior to the marriage of our son, we have started to reside in a flat on our building in the third floor and my son also used to reside with us in the same flat and even after marriage, my said son and his wife also used to reside with us in the same flat and ultimately in the month of August, 2015, my son and daughter-in-law asked us to allow them to live and stay in another flat on the third floor of the said building as they are not willing to stay with us anymore and considering their happy conjugal life, we also allowed them to stay separately in our own flat situated in the same building on the third floor. It is also to be mentioned here that during their stay with us, our son and daughter-in-law jointly have created tremendous mental torture, total disrespect upon me and my deceased husband and also threatened us with dire consequences and also threatened us to restrict our two daughters who are married and living separately at their respective matrimonial house, not to visit in our house with a view to look after us as it has already been stated that after one month of marriage of our son, we received severe mental torture from our son and daughter-in-law and they did not bother to look after us as and when we fallen ill, and at that time, our said two daughters have compelled to look after us and tried to maintain us according to their best effort.

6. That my husband was suffering from heart and liver diseases and he was undergoing treatment with the Doctors at Hyderabad and Bangalore and he used to visit every after 4 or 5 months either at Bangalore or Hyderabad for the purpose of his check-up and treatment and during the check-up period, we have compelled to take support of our two daughters who used to accompany with us and also bear the expenditure incurred thereon as our son and daughter-in-law neither ready to accompany with us nor they incur any expenditure towards the treatment and check-up of my husband. It is needless to mention the facts that we have already handed over a shop room in favour of our son wherefrom, our son has been carrying on business and finally, due to their constant mental torture, my husband expired on 16.04.2021 and even after demise of my husband, they did not keep any relation with me and also they did not bother to take any information about my health and maintenance.

7. That very recently, and also in past few months, our son and daughter-in-law have started to demand money and property from me putting me in fear of hurt for the purpose of extort money and property. Our son and daughter-in-law threatened me and my daughters to provide huge amount to them as well as created pressure upon us to transfer our own property in their names and when we expressed to decline their said proposal, they became more furious and started tremendous mental torture upon us by way of throwing

some offensive and abusive languages to us. They also threatened us with dire consequences by saying that if we fail to provide money and transfer the property in their name, my daughter-in-law in conspiracy with our son will not hesitate to lodge a false complaint against me as well as against my married daughters who are helped me during my old age and put us behind the iron bar and in one occasion, my said daughter-in-law brought the Police Personal by making a false complaint against me but due to the intervene with the well wishers and neighbors, the matter was resolved and in this way, they constantly, creating a terror and mental torture upon us. Not only that due to their ill-behaviour and threatening, my two daughters who used to help me, fear to visit in our house with a view to gathered information about my health and maintenance. Due to such type of activities of my son and daughter-in-law as mentioned above, I have been passing my every days in deep fear, mental trauma and anxiety at my old aged situation and recently, my son tried to attack upon me with some sharp cutting weapon with an intention to destroy my life permanently but somehow, I rescued myself from the hands of my son and daughter-in-law and thereafter, my son and daughter-in-law with the help of family members of my daughter-in-law have started to create tremendous pressure upon me to transfer our property in their names otherwise, they will teach me a good lesson.

I, therefore, request you to investigate into the matter and please take appropriate strong legal steps against my sons and daughter-in-law and others as per the provision of law so that, being a Senior Citizen, they should not disturbed upon me in any manner whatsoever and oblige thereby.
