I, Nitesh Jindal, son of Suresh Kumar Jindal, resident of 2nd Floor, Höuse No. 8, Neelkamal Apartment, Parnami Mandir Road, Siliguri, West Bengal – 734001. I hereby lodge this FIR against Girish Kumar and Karan Agrawal, Owner of Mahadev Trading Company, Rudrapur, Uttarakhand (GST no. 05EA0PK2482L1Z8) for non-My firm is siked-Lal Fullsari, P.S-NJP. payment of dues.

I am the owner of the firm - Yu-nut processing Industry (GST No. 19AACFY2913L1ZU) where we process, pack and market cashew nuts under the brand name 'Crunchy Cashews'. My Firm has supplied cashew nuts (wholes and broken) to Mahadev Trading Company, Rudrapur on March 3rd, 2022. The material was shipped through Safexpress Courier Service with Docket no. 102302325. The agreed amount for the product was ₹ 12,34,401 and I had issued an invoice with number 845 and E-way Bill with number 851211280350 to the person. The person had provided an advance of ₹ 7,00,000 and had promised to pay me the balance amount (₹ 5,34,401) within 3 days of material delivery but they have failed to do so till date.

I have made several attempts to contact the person and remind them of the payment but they have either ignored my calls or given false excuses. I have also sent them WhatsApp messages demanding the payment but they have not responded to them. I have attached copies of the invoice, E-Way Bill, Shipping Courier Docket slip, WhatsApp Chats and other documents as evidence of my claim.

The person's act of non-payment of dues is a clear case of cheating, fraud, and breach of trust. It has caused me financial loss and mental harassment. I request you to kindly register my FIR and take necessary action against the person as per law.
