Sub: FIR against Pilferage of Electricity

Sir,  
I do hereby lodge a complaint empowered by the Electricity Act, 2003, read with further amendments that Mr. Parimal Arya, S/O- Siben Arya, Village- Krishna Nagar Colony, P.O. - Sahudangi Hat, PS- New Jalpaiguri, District- Jalpaiguri, PIN- 735135 (Consumer ID: 401916177), has committed Theft of Electricity under section: 135(i)(a) & 138(b) of the Electricity Act, 2003, read with further amendments for the Domestic purpose as stated here under.

On 17.07.2023 at about 14:40 Hours, I, Sri Sourav Paul, AE (E) & Station Manager, Subhaspally CCC, WBSEDCL, along with 1. Mr. Amarasish Mohandeo, DE (E) & 2. Mr. Pranab Sikdar, Special Officer, attached with S&LP unit, Darjeeling Region Office, WBSEDCL & 3. Mr. Arnab Ray, J.E. (E) (Grade-II) & 4. Mr. Dillip Das, Contractual Reader of Spot-bill agency (M/S Sujanax), attached with Subhaspally CCC, WBSEDCL, entered into the Domestic premises of Mr. Parimal Arya, S/O- Siben Arya, Village- Krishna Nagar Colony, P.O. - Sahudangi Hat, PS- New Jalpaiguri, District- Jalpaiguri, PIN- 735135 (Consumer ID: 401916177), in order to inspect the service line incoming & leaving the meter as well as Supervisory Checking purpose.

During inspection it has been found that the aforesaid accused, Mr. Parimal Arya, S/O- Siben Arya, Village- Krishna Nagar Colony, P.O. - Sahudangi Hat, PS- New Jalpaiguri, District- Jalpaiguri, PIN- 735135 (Consumer ID: 401916177), was consuming Electricity dishonestly in unauthorized manner by Unauthorized Reconnecting the 'Deemed Disconnected' service connection having Consumer ID: 401916177 & Meter No.: BB0142124 which was disconnected on 02.12.2021 due to having outstanding dues of electricity. Moreover, the last meter consumption up to which billing was raised is 2199 KWH. And, during inspection on 17.07.2023, the service connection was found 'Physically Live' i.e. the accused person was found consuming electricity through that meter at his Domestic premises for Domestic purposes & the aforesaid energy meter was found performing normal having last reading of 4755 KWH dated: 17.07.2023 during seizure of the meter. Thus the service connection was used in unauthorized manner & WBSEDCL incurred huge amount of loss in revenue.

As Theft was detected I immediately with the help of my Technical staff disconnected his Service Connection and seized one number Single Phase Energy Meter having SI No.: BB0142124, make: Bentec Bharti, Rating: 240V, 5-30A, 3200 imp/unit (L.R.: 4755 KWH) connected with some portion of Incoming & Outgoing wires which have been used for Unauthorized reconnection of the 'Deemed Disconnected' service connection (Consumer ID: 401916177) & consuming electricity dishonestly in unauthorized manner at the aforementioned Domestic premises for the Domestic purposes under a proper seizure list as well as the seized articles were properly packed, labeled and sealed at the spot after observing necessary formalities in presence of the Inspection Team Members & Witnesses & Witness of the Accused Person i.e. his wife. And, Copies of Notice, Inspection Note & Seizure List were handed over to the witness of the accused person i.e. his wife at the inspection spot. The inspection team members left the aforesaid premises at 15:10 Hours on the same day after observing all formalities.

So the accused Mr. Parimal Arya, S/O- Siben Arya, Village- Krishna Nagar Colony, P.O. - Sahudangi Hat, PS- New Jalpaiguri, District- Jalpaiguri, PIN- 735135 (Consumer ID: 401916177), has committed Theft of Electricity under section: 135(i) (a) & 138 (b) of the Electricity Act, 2003, read with further amendments for the Domestic purpose.

So I request you to take cognizance against the aforementioned accused person on this matter and consider this complain as FIR to initiate further necessary action from your end.
