I, SI Pradeep Diyali of New Jalpaiguri Police station, Siliguri Police Commissionerate do here by lodge this written complaint against above noted 01 (One) arrested accused persons to the effect that today 19.07.2023 at about 1425 hrs I received a specific source input that one Person would be coming from Coochbehar in a Bus with huge consignment of Ganja for his clandestine disposal to deliver the same to his design Cumtomer at Murder More, Fulbari. The matter was diarized vide NJP PS PS GDE No. 843 Dt. 19.07.2023 and I informed the matter to SI Partha Sarathi Das, Officer-In-Charge, New Jalpaiguri Police Station, Siliguri Police Commissionerate in writing a letter to him and expressed the entire information. As per his kind direction myself along with other officers and force named ASI Dhruba Mishra, C/1044 Hari Khwar, C/1043 Uttam Dey, VP/13 Jamirul Islam all of NJP PS, Siliguri Police Commissionerate being headed by me left for Murder More, Fulbari, under New Jalpaiguri PS, Dist.- Jalpaiguri by govt. vehicle with investigation kit to verify the veracity of the information in hand vide NJP PS GDE No 844 dated 19.07.2023 and M.C.C. No. 1603 dated 19.07.2023. Further I also informed the Videographer namely Tapan Mandal s/o Testo Mandal of Bhola More, PS- NJP, Dist.- Jalpaiguri to be present at Murder More, Fulbari under New Jalpaiguri PS, Dist.-Jalpaiguri to prepare the Video of whole process of search and seizure if any. Under this circumstances any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidences of facility for the escape of the offender. At about 1455 hrs we arrived at Muder More, Fulbari under New Jalpaiguri PS, Dist.-Jalpaiguri and on the way to the spot, I called two independent witnesses namely (i) Sukamalsen Gupta s/o Lt. Subirsen Gupta of Shaktigarh, Road No. 03, PS-New Jalpaiguri, Dist.- Jalpaiguri (ii) Buddhadev Shah s/o Arun Saha of Surasen Colony, Ward No.-34, PS-New Jalpaiguri, Dist.- Jalpaiguri and disclosed our identity and informed them about the information in hand and requested them to accompany us and remain present in the whole process during search and seizure if necessary with a written letter and necessary permission of their presence and act as witnesses under relevant provision of law. After arrival at the spot and as identified by the source we found that one person with huge black Color Adidas beg is standing at Muder More, in opposite side of Traffic Booth Office, Fulbari which was matched with our information. Accordingly, we apprehended 01 person who disclosed his identity as noted above.

After disclosing our identity, we detained the above noted person with a strong reason to believe that he illegally possessing Ganja in he bag which was carrying for clandestine disposal the same at Fulbari area for his wrongful gain. On being asked he confessed that he possessed Ganja in his possession in the bag carrying by him. I then gave him option in writing whether he wanted to be searched in presence of Executive Magistrate or by any Police Gazetted Officer. The apprehended person agreed to be searched by any one of them. Further, I served him Notice in accordance with provisions of law in this regards. I also offered the independent witnesses and the apprehended person to search our Police Party as per provision of law but he denied to search police party. Accordingly, I informed the matter to the Officer-In-Charge, NJP PS and as per his kind order I informed the fact to Shri Suraj Thakuri, WBPS, Assistant Commissioner of Police, East-II, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, of SPC for the day regarding the interception of the with one person along with one big bag possessed of Ganja and requested him to come to the spot and to supervise the search and seizure being a gazette officer. Accordingly at 14.55 hrs Shri Suraj Thakuri, WBPS, Assistant Commissioner of Police-Eas-II, Siliguri Police Commissionerate arrived at the spot and accordingly, I disclosed his identity to the detained person as Special
