It is to intimate that, On 16 July 2023 about 0330 hrs, On specific info of G/Rep CT/G Arvind kumar. Sh. M.P. Shah, AC A/with SO-01 and ORs-03, total-05 (including G-Rep) laid ambush w.c.f. 0240 hrs in depth area of Lokdown more (near Village Kalangini) under AOR Fulbari at about 0330 hrs ambush party saw some suspicious movements of miscreants A/with cattle heads near bamboo vegetation. Ambush party challenged to the miscreants. On seeing the ambush party the miscreants ran away towards Village Pradhanpar by taking the advantage of darkness. Ambush party sized 04 Rathi origin medium size cattle Rs. 10658 x 04 worth Rs. 42632 /- as outgoing/ unclaimed / near Village Kalangini in alignment between BFL No 16-17, between BP No 732/4-s TO 732/5-s. No, any injury noticed/reported to any smuggler/miscreant. The seized cattle handed over to Dhyan Foundation. FIR is being lodged late due to delay in handing/taking of cattle with Dhyan Foundation.
