Sir,

With due respect I, ASI Rabi Tamang of Ambari-Falakata OP, PS-NJP, SPC, would lodge a written complaint to the effect that on 18.07.2023 at about 23.15 hrs while performing night mobile van patrolling duty I have received information from duty officer ASI. Md. Jamirul Haque that an incident of RTA was occurred at Telanipara on Nawapara-Sahudangi road. Accordingly I had been to the spot and found that one person was lying on the road in unconscious condition with several injuries on his person and a motorcycle bearing registration No. WB-74-BN/7555 was also lying there in damaged condition. Immediately the said injured person was shifted to Maharaja Aggrasen Hospital, Fulbari with the help of local inhabitants. During local enquiry it could be learnt from the local people that a loaded Dumper bearing registration No. WB-73-G/4496 dashed the said person who is on his motorcycle and fled away without attending him. In course of further enquiry it could revealed that the name & address of the injured person is Tapash Debnath S/O Manmohan Debnath of Nawapara, P.O-Sahudangi hat, PS-NJP, Dist-Jalpaiguri. Accordingly I have conveyed the same to O/C, Ambari-Falakata OP, PS-NJP, SPC.

Now, today, i.e on 20.07.2023 I came to know that the said injured person namely Tapash Debnath S/O Manmohan Debnath of Nawapara, P.O-Sahudangi hat, PS-NJP, Dist-Jalpaiguri was succumbed to his injury at Maharaja Aggrasen Hospital, Fulbari.

Hence, in view of the above noted circumstances, I pray to you that a specific case under proper section of law may kindly be started against the driver of the offending vehicle bearing registration No. WB-73-G/4496 and arrange for its investigation.
