Respected Sir,

I, Karan Tiwari, Son of Sachidanand Tiwari, residing at Ananda Para, Ward No.17, Under Jalpaiguri Municipality, P.S.- Kotwali, Dist- Jalpaiguri hereby inform you that I am a small businessman by profession and during the course of business I met one Palash Saha details of whom are being furnished below. After preliminary instruction he represented himself as a reputed business personality having good contact with political leaders in Kolkata and Delhi and he also assured me to arrange the license of dealership of B.P.C.L, and also asked me to act his assistant to contact persons who are interested to take the dealership of B.P.C.L in several areas within the territory of North Bengal.

Even the said Palash Saha also allured me to invest near about 30 lakhs to get a dealership of B.P.C.L. within the jurisdiction of Siliguri-Jalpaiguri area. And on good faith I introduced him with some persons within the jurisdiction of Bhaktinagar P.S. who were also interested to take the dealership of B.P.C.L. It is pertinent to mentioned that since 28/05/2022 to 01/03/2023 he took amount of Rs.6 lakhs (approx) through UPI at his account along with two of his associate Akash Kundu and Bittu Biswas. In an assurance to give dealership of B.P.C.L. within Siliguri-Jalpaiguri area in addition he also took some amount who met with him through me.

But unfortunately as on date he did not keep his promise to give the dealership of B.P.C.L. to any one of us. Result of which those persons who kept reliance upon me and gave money to said Palash Saha became aggrieved and one of them Lodged a fabricated Complaint against me at Bhaktinagar P.S. and I was intercepted and after lapse of some period I was enlarged on bail by the Ld. Jurisdictional Court.
