Sub: Compliant against demolition of boundary wall and theft at
our land at Bandhu Nagar

I, Rajesh Agarwal, Director of Kishaloy Housing Pvt. Ltd. at Ramkrishna Samity Building, Sevoke Road, P.O Siliguri, Dist Darjeeling, do hereby give you this for information and for taking necessary actions on the following:

That we had purchased a piece and parcel of land approx 5.98 acres situated at Mouza Ambari Falakata, J.L No. 22 at Jugivita Mouza in the year 2012 and since the date of purchase the aforesaid land is well demarcated with Pukka Boundary wall and gate at front side and back side since from the very beginning.

That on 19.07.2023 I engaged my labourers to construct a boundary wall at the east side of our land to close the gate.

Today i.e. on 21.07.2023 at about 4:30pm when I was inspecting our aforesaid land to my shock and surprise that our constructed boundary wall has been demolished by some unknown miscreants and the said miscreants have illegally removed sand, bricks, iron rods etc by way of theft and by way of illegally removing the same leading to a loss of Rs. 3,00,000/- approx.

Therefore I request you to kindly do the needful and take necessary action against the wrongdoers in the above matter and book them into the justice, so that we can develop our works smoothly.
