I, Subroto Ghosh, Son of Soumitra Ghosh, resident of Beldangi, P.S. Matigara, Siliguri, Dist. Darjeeling, would like to inform you that I am a business man and deal with business of milk product such as Paneer, Ghee, Dahi and Milk etc., and my business center is situated at Old Matigara Road, Near Kalimandir, which is under the jurisdiction of the Pradhan Nagar police Station. My shop is looking after by my cousin brother namely Ujjal Roy, I used to supply the said milk product on different places. On 18.07.2023 at about 11:00 A.m. when I was preparing to proceed to supply the good to some of my customer who were order for the same and at that material point of time one Tapash Paul, resident of Pati Colony, Ward no. 47 of S.M.C, Gali No. 7, suddenly without my provocation and/or any cogent reason, probably due to business rivalry hit me with fist and blows on my head as well as upper portion of my eye brow with the help of iron ring which he wore on his finger and also hitting me by a stone with very strongly on my head and by which I sustained severe injury on my person. Due to sudden huge attack I became unconscious for a while and after recovery I felt huge pain of my head along with adjoining portion and instantly was brought to the Siliguri District Hospital and doctor prescribed Medicine along with some test.


