Sir,

Yesterday (23/07/23) I Mrs. Alkayana Roy Tiuky married to Mr. Dipak Ranjan Roy for 22 years. I am a resident of Shantiniketan Apt. BL no. 7 S/E was brutally beaten by my husband including my youngest son (Pinak Ranjan Roy) approx 10:43pm. He started behaving like this for no reason and started beating my youngest son for, I went to stop him but he pulled me back and started hitting me repeatedly. Me and my son were scared and shouted for help, he didn't even stop there and broke my phone when I was trying to dial the helpline number.

As I share the ownership of the house I have no place to stay and he forced me to leave the house. Due to this behaviour for the past 12 years my eldest son left the house and my youngest son is totally traumatized. We both completed our checkup at NBMCH (1:30am), (24/07/23).

I request you to take the action as soon as possible.
