In producing herewith 80 pcs damaged condition corrugated Tin and 12 Pcs flags of KPP along with original seizure list and do hereby lodged this complaint against the below noted persons namely (1) Smt. I SI Ganesh Ray of NBMC Police Out Post under Matigara PS, SPC do hereby lodge this written complaint against the above mentioned accused persons and others to the effect that, today on 24.07.2023 at 07:45 hrs I received an information from Kawakhari Medical More, that some female persons were occupying a plot of land under Mouza – Kawakhari illegally under the Flag of KPP which is under sub judice. The matter diarized in NBMC OP General Diary vide NBMC OP GDE No-590 dated 24/07/2023. Accordingly I informed the matter to O/C NBMC OP, OC Matigara PS, B.D.O Matigara & BL & LRO Matigara and I along with other officers and forces left for Kawakhari Medical More to work out the information. After reaching the spot at Kawakhari Medical More I found that approx 70 to 80 persons (approx) are occupying a plot of land under the Flag of KPP and making some tin shed and tin fencing room illegally.

There after BL & LRO Matigara Block Shri Dipen Lama, Engineer of BDO Office Matigara Shri Angshuman Chakraborty & O/C Matigara PS arrived at the PO. During preliminary enquiry it could be found that a Title Suit is going on over the said land in between one Basudeb Ghosh of Thiknikata and Arjun Roy and others of Kawakhari Medical More since long vide Title suit no 02/2018 where Ld Civil Judge Jr. Division Siliguri passed and order that the defendants are hereby restrained from disturbing the peaceful possession of the plaintiff upon the suit land till disposal.

During further enquiry it could be found that an order has been passed by the Hon'ble High Court, Kolkata, Circuit Bench at Jalpaiguri that, nobody shall disturb to the plaintiff Basudeb Ghosh to his peaceful position of said land and also directed to police to maintained peace regarding the said land in question. During enquiry it could be learnt that the above noted accused persons and others were violated the Court order. In the mean time the above noted accused persons leave the P.O. After seeing the Police party as well as BL & LRO Shri Dipen Lama, Engineer of BDO Office

Matigara Shri Angshuman Chakraborty the above noted accused persons were fled away from the spot.

During enquiry it was collectively decided that the illegal tin and bamboo structure should be seized as there is no claimant at that moment. Accordingly I seized 80 pcs damaged condition corrugated Tin and 12 Pcs flags of KPP after preparing seizure list in presence of witnesses.

Under the above circumstance I pray before you that a specific case may kindly be started against the above mentioned accused persons and others and arrange for its investigation.
