With due respect **I SHEETAL TAMANG D/O SRI PREMDIL TAMANG** is Buddhist by religion, Indian by nationality, Business by occupation, residing at Satyajit Nagar, Mallaguri Tea Auction Road, Champasari, P.O. Pradhannagar, P.S-Pradhannagar, District-Darjeeling, in the State of West Bengal- 734003, would like to inform you the following facts:-

That I am the recorded owner of land measuring 33 decimals recorded in khatian No 4014, in Plot No.648/720 (L.R), mouza Baragharia, under Matigara Police Station, Dist Darjeeling vide a registered Deed being No.1 11877/2022 registered in the office of ADSR Siliguri-II at Bagdogra, Dist Darjeeling.

That I had build a ware house for the construction of the wall and had also installed electricity meter bearing consumer I.D No.402944661 on my above said land.

That today dated 22/07/2023 at around 4.00 pm I recived a call from one of my labour working there at my abovesaid land that one named **Subash Chand kumbhat director of Darjeeling Automobiles Pvt.Ltd** having its office at Burdawan Road, Siliguri, Dist Darjeeling West Bengal along with his goons had entered my said land forcefully and damaged my boundary and had demolished the ware house and also damaged the electricity meter and main gate and thus after damaging the gate they had installed a new lock to my gate, intention to grab my land.

Therefore I reached at my land and find that my electric meter is being damaged along with gate and ware house and a new lock is being installed to the gate.it is very painful to state you that I belongs to Shedule Tribe and the previous recorded land of the said land belongs to Shedule Tribe and thus without any valid permission of the concern office how the said land belongs to a general caste people.

This is to inform you that they are very dangerous people and now my life is in danger and they also wants to grab my land forcefully, and they wants to take possession of the land with the help of other local brokers and land grabbers.

therefore this is our humble submission to lodge specific complaint against **Subash chand Kumbhat** so that I can live our life in peace and harmony.
