## Sub : F.I.R.

Sir,

- I, Sri Dhiraj Ghosh, Son of Late Dhirendra Nath Ghosh, resident of Gossainpur, Post Office & Police Station Bagdogra, District Darjeeling, Pin 734010, beg to lodge this complaint as under:
- 1. That Sri Sisir Sunam and his father, Sri Goutam Sunam, residents of Nimai, Post Office & Police Station Matigara, District Darjeeling, claiming to be the owners of a plot of land measuring 0.31 Acre at Mouza Nimai, Police Station Matigara, District Darjeeling, had approached me to purchase the said land for the consideration money of Rs.2.00 Crore (Rupees Two crore) only. I, fully relying on their claim of ownership of the said land and also finding the consideration money as a reasonable and prevailing in the present market, had accepted the said proposal and agreed to purchase the said land for the total consideration money of Rs.2.00 Crore (Rupees Two crore) only.
- 2. That immediately thereafter, as per the requests and demands of said Sri Sisir Sunam and his father, Sri Goutam Sunam, I started making payment of moneys as advances to them on different date/dates and till date a total sum of Rs.1.60 Crore (Rupees One crore sixty lakh) only has been paid to them, on account of earnest money.
- 3. That after making payment of the said considerable amount of Rs.1.60 Crore (Rupees One crore sixty lakh) only to said Sri Sisir Sunam and his father, Sri Goutam Sunam, I started requesting them to execute and register the necessary sale deed with regard to the said land measuring 0.31 Acre to and in my favour, after receipt of the balance consideration money of Rs.40.00 Lakh (Rupees Forty lakh) only, but they, on all the occasions, avoided to execute and register the Deed of Sale in my favour on various pretexts for their unlawful gain.
- 4. That from the aforesaid acts and conducts of Sri Sisir Sunam and his father, Sri Goutam Sunam, it is crystal clear that they, dishonestly induced me to make payment of the said total sum of Rs.1.60 Crore (Rupees One crore sixty lakh) only to them for their wrongful gain.
- You are, therefore, requested to enquire into the above matter and take immediate steps against said Sri Sisir Sunam and his father, Sri Goutam Sunam, after starting a specific case against them.
