Respected Sir,

I, Rahul Gupta, Proprietor of M/s Kichori Prasad Jewellers, Siliguri at Verma more, Hill Cart Road, Siliguri, to inform you that a family by name Smt. Priyanka Malik (wife) Sharma and Mr. Shivam Malik (husband), (we know the name while enquiring), has visited my shop to purchase gold chains at about 5:35 PM in the evening. While showing gold chains to the family, the wife (Priyanka Sharma Malik) has taken 2 (two) nos. of gold chain from me. To let on her husband (Mr. Shivam Malik), in between that her husband cleverly exchanged one gold chain with a ordinary fake chain (City Gold) and ran out from my shop, but I/we catch the wife (Priyanka Malik) at my shop. All the incident has been recorded clearly in my CCTV footage. After that I/we called up at local Police Station and inform all to the Investigating officer.

Soon a mob of persons came in front of my shop and gathered the girl and started agitating in order to avoid untoward situations, I ringed at PS by phone.
