On 23rd July 2023 time 2pm a Bikash Thakuri a Bishal Thakuri (Bhim Thakuri) Binod Thakuri, Nirmaya Thakuri who are my neighbour, hit me; my mother (Mina Thapa) and grand mother (Sushma Thapa). They have physically assaulted me and have harassed me.

Such assault and harassment has been happening on daily basis. Earlier also Bishal Thakuri (Bhim Thakuri) has intentionally hit my mom on her breast during such conflict.

I would urge the law and justice of India to take strict action against them.
