producing herewith one (01) arrested accused person namely Govind Kumar Chowdhury (20)s/o Lt. Ramesh Chowdhury of near Marigold School, Gangtok Municipal Corporation, Sicheygoan, PS Sadar, East Sikkim, State - Sikkim with the following articles under proper seizure as per seizure list;

- a) One Black colour Bag containing 25 (Twenty-Five) bottles of Chlorpheniramine Maleate & Codeine Phosphate and Syrup, styled as PHENSEDYL, having Batch No. PHC22058, Mfg. Date. 06/2022; Expiry Date. 11/2023 & M.R.P. Rs. 205.31 per bottle, each bottle containing 100 ml, which was recovered and seized from the exclusive and conscious possession of Govind Kumar Chowdhury and marked as "Exhibit- A".
- b) One (01) bottle of Chlorpheniramine Maleate & Codeine Phosphate and Syrup, having Batch No. PHC22058, Mfg. Date. 06/2022; Expiry Date. 11/2023 & M.R.P. Rs. 205.31, styled as PHENSEDYL, randomly taken from Exhibit A and taken as sample for examination and marked as Exhibit "A-1".

I, SI Abhishek Theengh (32), S/O- Suchandra Kumar Theengh of Pradhan Nagar Police Station, Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted accused person namely Govind Kumar Chowdhury (20)s/o Lt. Ramesh Chowdhury of near Marigold School, Gangtok Municipal Corporation, Sicheygoan, PS Sadar, East Sikkim, State - Sikkim to the effect that on 25.07.2023 at about 18.20 hrs, I received a specific source input that one person possessing huge quantity of Chlorpheniramine Maleate & Codeine Phosphate and Syrup was standing at Regulated Market, 2nd Gate, Exit Gate, under Pradhan Nagar PS to sell the same to his designed local customers. The matter was diarized in Pradhan Nagar PS GDE No. 1600/23 Dt. 25.07.2023. Subsequently, I informed the matter to you on written and with your prior permission and being directed, myself along with ASI Manoj Kumar Roy, ASI Biplab Kumar Das, CV-646 Baban Das, CV-992 Jagadish Biswas all of Pradhan Nagar PS, SPC, and after being contacted to the Videographer Somnath Chatterjee S/O Sushil Chatterjee of Arubindo Pally, P.O.- Rathkhola, P.S. - Siliguri, Dist. - Darjeeling and with investigation kit left for Regulated Market, 2nd Gate, Exit Gate, under Pradhan Nagar PS by Govt. vehicle to verify the veracity of the information. This refers to Pradhan Nagar PS GDE No. 1601/23 Dt. 25.07.2023 and M.C.C No- 1835 Date- 25.07.2023.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

After reaching at Regulated Market, 2nd Gate, Exit Gate, under Pradhan Nagar PS at around 18.35 hrs, I requested two persons as independent witness by notice namely (1) Prakash Pradhan (32) s/o Madan Pradhan of Medical More, PS Matigara, Dist. Darjeeling and (2) Dilip Biswakarma (35) s/o Balaram Biswakarma of Pokaijote, PS Pradhan Nagar, Dist. Darjeeling and made them aware of the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed and thereafter being pointed by my source detained 01 (One) person mentioned above who was standing at Regulated Market, 2nd Gate, Exit Gate, under Pradhan Nagar PS. He had carried one black colour Bag under his possession. Thereafter, we disclosed our identity and the information in hand and stated him that he as well as the bag under his possession will be searched for the purpose. And, I gave him option in writing to be searched in presence of an Executive Magistrate or by any Gazetted Officer upon which he agreed to be searched in presence of any one of the above.

I also offered the independent witnesses and the accused person to search our Police Party as per provisions but he did not search the police party. Consequently, I informed the matter to you and as per your kind order, I informed to Shri Moksedur Rahaman, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC for the day, regarding the interception of the accused person suspected to be possessed Codeine Phosphate Chlorpheniramine Maleate Syrup illegally and requested him to come at Regulated Market, 2nd Gate, Exit Gate, under Pradhan Nagar PS to remain present and to supervise the search and seizure.

Accordingly at 18:55 hrs Shri Moksedur Rahaman, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC arrived at the spot at Regulated Market, 2nd Gate, Exit Gate, under Pradhan Nagar PS as Special Executive Magistrate, SPC and in presence of two independent witnesses and hereafter I searched the detained person following all formalities, keeping his decency and recovered the above noted articles from the exclusive and conscious possession of the accused person namely Govind Kumar Chowdhury (20)s/o Lt. Ramesh Chowdhury of near Marigold School, Gangtok Municipal Corporation, Sicheygoan, PS Sadar, East Sikkim, State - Sikkim.

Further, on demand in presence of Shri Moksedur Rahaman, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC, the detained person namely Govind Kumar Chowdhury, on being asked, failed to produce any valid documents/papers or explanation for possessing of such a huge quantity of 'Codeine Phosphate & Chlorpheniramine Maleate Syrup' beyond the prescribed limit.

Thereafter, I seized 25 (Twenty-Five) bottles of Chlorpheniramine Maleate & Codeine Phosphate and Syrup, styled as PHENSEDYL, having Batch No. PHC22058, Mfg. Date. 06/2022; Expiry Date. 11/2023 & M.R.P. Rs. 205.31 per bottle, each bottle containing 100 ml from the exclusive and conscious possession of Govind Kumar Chowdhury which was kept inside one black colour Bagunder proper seizure list in presence of independent witnesses and Shri Moksedur Rahaman, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, SPC obtaining their signature and being acknowledged by the accused person.

Subsequently, I labelled and sealed the seized articles in presence of Shri Moksedur Rahaman, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, SPC and independent witnesses and the accused person namely Govind Kumar Chowdhury. The whole process of seizure was made in between 19.10 hrs to 19.55 hrs with the videography.

Being further asked, the apprehended person namely Govind Kumar Chowdhury admitted in presence of Shri Moksedur Rahaman, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC and other independent witnesses that he have procured Codeine Phosphate Chlorpheniramine Maleate Syrup clandestinely for the purpose of selling the same in high rate to his designed local customers for his personal gain by illegal means.

On further being asked, he also disclosed that he have been dealing in this business of procuring and selling of Codeine Phosphate Chlorpheniramine Maleate Syrup based drugs along with his associates illegally for last few months for their wrongful gain and has been chiefly selling in Siliguri, Sikkim and its adjacent areas.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused person namely Govind Kumar Chowdhury is involved in procuring and selling Codeine Phosphate Chlorpheniramine Maleate Syrup based drugs illegally contravening the norms of NDPS Act.

Then, I arrested the above noted accused person namely Govind Kumar Chowdhury after observing all formalities and informing the ground of their arrest and issued necessary Memo of Arrest at 19.57 hrs respectively.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused persons namely Govind Kumar Chowdhury (20)s/o Lt. Ramesh Chowdhury of near Marigold School, Gangtok Municipal Corporation, Sicheygoan, PS Sadar, East Sikkim, State - Sikkim and others and arrange for its investigation.
