Sir,

In producing herewith 02 (two) arrested accused persons namely 1) Sarook Malik (22 years), s/o-Babuddin Khan of Madrak, PS_Madrak, Dist. Aligarh, Uttar Pradesh and 2) Bablu (23 years), s/o-Suresh of Madrak, PS-Madrak, Dist. Aligarh, Uttar Pradesh along with the following under mentioned seized articles which as follows:-

1. Total 14 packets of shampoo styled as Tresemme each packet 03 containing pcs that is $(14 \times 3) = 42$ pcs.
2. Total 24 packets of shampoo styled as Dove each packet containing 03 pcs that is $(24 \times 3) = 72$ pcs.
3. Total 18 packets of shampoo styled as L'Oreal Paris each packet containing 03 pcs that is $(18 \times 3) = 54$ pcs.
4. Total 17 packets of shampoo styled as Clinic Plus each packet containing 03 pcs that is $(17 \times 3) = 51$ pcs.
5. Total 10 packets of shampoo styled as Head & Shoulder each packet containing 03 pcs that is $(10 \times 3) = 30$ pcs.
6. Total 18 packets of shampoo styled as Sunslik each packet containing 03 pcs that is $(18 \times 3) = 54$ pcs.
7. Total 07 packets of shampoo styled as Pentane each packet containing 03 pcs that is $(7 \times 3) = 21$ pcs.
8. Total 03 packets of shampoo styled as Himalaya each packet containing 03 pcs that is $(3 \times 3) = 09$ pcs. Seized from their possession with relevant documents before you with a request for starting specific case and making arrangements for its investigation.

The fact of the case in brief is that today on 27.7.2023 at 06:15 hrs while myself along with force were performing Mobile Van duty, reaching to PNT Gully, Jalpaimore, PS-Siliguri, found two unknown persons moving suspiciously having four bags with them and seeing Police Van they started to flee away from there. On hot chase, Police team could be managed to intercepted both of them at the above noted place and on enquiry, it is found that both the suspects have procured four bags with huge numbers of Shampoo bottles of different companies which seems to be seems to be duplicate. On demand, both the persons could not able to produce any valid documents in support of those items and it appears that those suspects had made duplicate copies of the Shampoo bottles and thus had infringed the copyrights of the registered companies by adapting the logos/names of the registered companies illegally for their wrongful gain. On further grilling both the suspects had made in coherent statement before police regarding the seized items as well as their names and address. It is also appears that both the suspects caused loss of Revenue to the Govt. by making duplicate copies of the Shampoo bottles and using them as genuine for the purpose of cheating public in general for their wrongful gain. Accordingly, I seized those items which appears to be duplicate shampoo after preparing proper seizure list as per law u/s 102 of CrPC and arrested both of them u/s 41 of CrPC preparing proper memo of arrest in presence of witnesses after observing all legal procedure.

Hence, I pray before you that an order may kindly be passed for making arrangement for investigation of the above noted fact and oblige.
