Sir,

With due respect, I am producing herewith the arrested accused persons namely (i) Subhash Das (19) s/o Madan Das of Fulbari Pachim Dhantala, Murder More, PS- New Jalpaiguri, Dist.- Jalpaiguri (ii) Sahin Sekh (20) s/o Majibur Sekh of Fulbari Pachim Dhantala, Murder More, PS- New Jalpaiguri, Dist.- Jalpaiguri (iii) Md. Netabul (25) s/o Serajul Mahammad of Fulbari, Battalion More, Purba Dhantala, PS- New Jalpaiguri, Dist.- Jalpaiguri (iv) Surja Singh (19) s/o Hari Singh of Baribhasa, 25 Star Club, PS-NewJalpaiguri, Dist.- Jalpaiguri and the following articles under seizure :-

1. One Iron Rod measuring 45 CM in length, one Torch Light and One Blunt Iron Road from the possession of accused Subhash Das (19) s/o Madan Das of Fulbari Pachim Dhantala, Murder More, PS- New Jalpaiguri, Dist.- Jalpaiguri.
2. One Hasua and One Bhojali measuring 55 Cm in length from the possession of accused Sahin Sekh (20) s/o Majibur Sekh of Fulbari Pachim Dhantala, Murder More, PS- New Jalpaiguri, Dist.- Jalpaiguri
3. One Torch Light and One Small Hammer and Knife from the possession of accused Md. Metabul (25) s/o Serajul Mahammad of Fulbari, Battalion More, Purba Dhantala, PS- New Jalpaiguri, Dist.- Jalpaiguri
4. One Blunt Iron Rod and One Torch Light One Iron Hammer from the possession of Surja Singh (19) s/o Hari Singh of Baribhasa, 25 Star Club, PS-NewJalpaiguri, Dist.- Jalpaiguri.

I, SI-Pradeep Diyal of NJP PS, Siliguri Police Commissionerate beg to state that on 23.07.2023 at 0015 hrs I received a secret source information that a gang of miscreants come to Porajhar, PS- New Jalpaiguri, Dist.- Jalpaiguri with deadly weapons and assembled there and making preparation for committing dacoity at Porajhar. Accordingly, I informed the fact to you and diarized the fact in General diary vide NJP PS GDE No 1129 dated 23.07.2023. As per kind order myself along with C/1044 Hari Kherwar, VP/13 Jamirul Islam, C/453 Uttam Dey, all are of New Jalpaiguri PS, Siliguri Police Commissionerate left for Porajhar, PS-New Jalpaiguri, Dist.- Jalpaiguri to work out the information in hand. I also informed the fact to night RT Van officer SI-Prasan Tamang of New Jalpaiguri PS, Siliguri Police Commissionerate along with force and directed him to come to Porajhar to accompany with us. At about 0035 hrs on 23.07.2023 we arrived at Porajhar, PS-New Jalpaiguri PS, Siliguri Police Commissionerate. After a while SI-Prasan Tamang along with force came to Porajhar, near Porajhar Primary School and accompany with us. After arrival of the spot and as identified by the source we found that 08/09 persons assembled in a dark place at Porajhar, near Porajhar Primary School, under New Jalpaiguri PS, Dist.- Jalpaiguri and they were whispering in a very low voice. Accordingly we cordoned the place properly and approach towards them very slowly and carefully. But seeing the police party they started to flee away but we the police party managed to apprehended 04 (Four) of them. On interrogation the apprehended accused persons disclosed their name and identity as noted above and also disclosed that they assembled there to commit dacoity in a house at Porajhar area. They also stated that others 05/06 associates were able to fled away from the spot by taking advantages of darkness. On search of the apprehended accused persons found (i) One Iron Rod measuring 45 CM in length, one Torch Light and One Blunt Iron Road from the possession of accused Subhash Das (19) (ii) One Hasua and One Bhojali measuring 55 Cm in length from the possession of accused Sahin Sekh (20) (iii) One Torch Light and One Small Hammer and Knife from the possession of accused Md. Netabul (iv) One Blunt Iron Rod and One Torch Light One Iron Hammer from the possession of Surja Singh (19). During further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night. Finally they admitted their guilt and disclosed that they had assembled there and taking preparation for committing dacoity in a house at Porajhar area. Accordingly, I seized the above noted articles under proper seizure list and arrested the above noted four accused persons under proper memo of arrest and observing all the formalities of arrest. The search seizure and arrest made in between 0115 hrs to 0225 hrs on 23.07.2023.

Under the above noted fact and circumstance, I therefore pray to you that a specific case under proper section of law may kindly be started against the arrested accused persons namely (i) Subhash Das (19) s/o Madan Das of Fulbari Pachim Dhantala, Murder More, PS- New Jalpaiguri, Dist.- Jalpaiguri (ii) Sahin Sekh (20) s/o Majibur Sekh of Fulbari Pachim Dhantala, Murder More, PS- New Jalpaiguri, Dist.- Jalpaiguri (iii) Md. Netabul (25) s/o Serajul Mahammad of Fulbari, Battalion More, Purba Dhantala, PS- New Jalpaiguri, Dist.- Jalpaiguri (iv) Surja Singh (19) s/o Hari Singh of Baribhasa, 25 Star Club, PS-NewJalpaiguri, Dist.- Jalpaiguri and others and arrange for its investigation..
