Total of 30 bottle of Himalayn Gold 60 UP, each bottle containing 600 ML,total of 18.00 litres, out of which one bottle taken as sample for examination.

I, SI Abhishek Theengh of Pradhan Nagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one accused person named Debrabroto Mohanto (40) S/o Birendranath Mohanto of Samarnagar, PS Pradhan Nagar, Dist. Darjeelingto the effect that today on 28.07.2023, while performing mobile van duty received a source information at around19:30 hrs. that one person has been selling huge quantity of illegal liquor at Samir Hotel under Pradhan Nagar Police Station without any valid license.

Accordingly, I informed the matter to your kind notice and as per your kind direction I along with CV/223 Swapan Chettri and CV/128 Ajay Kr. Sahani had been to Samir Hotel under Pradhan Nagar PS to verify the veracity of source information. On reaching there and as identified by the source found that the above mentioned person was selling openly at his hotel styled as Samir Hotel under Pradhan Nagar PS, SPC.

Subsequently, I along with my force was able to detain the above noted person. Subsequently on being asked the apprehended person disclosed his name and identity as noted above. On demand he failed to produce any valid license/papers for selling such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last 06 (six) months for his illegal gain.

Then I seized and labeled the above mentioned illegal liquor under proper seizure and arrested the above-mentioned person named Debrabroto Mohanto (40) S/o Birendranath Mohanto of Samarnagar, PS Pradhan Nagar, Dist. Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 19:35 hrs to 20:45 hrs at the spot and arrested him after informing the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Debrabroto Mohanto (40) S/o Birendranath Mohanto of Samarnagar, PS Pradhan Nagar, Dist. Darjeelingunder proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
