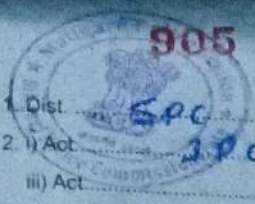

Sir,  
I, RUPCHAND DAS, son of Sri. Sudhir Chandra Das, resident  
of Deentala, Kawakdali, P.O. Sushroutanagar, P.S. Maligara,  
Dist. Darjeeling, would like to inform you that I am a TOTO  
driver by occupation. Four (4) years ago, I had married to  
to one RAJA KUMI DAS, O/o. Dulal Khatria according to Hindu  
rites and customs by performing all marriage ceremonies and  
started to live with her jointly along with my parents  
and two other brothers. Since our marriage my said wife  
use to misbehave with me and my family members.  
She said that she was not agreed to marry me. She was  
in love with other person. Her parents forced her to marry  
me. She is not ready to continue our marriage. I tried to  
change her nature and character in all these years  
but in-vain. She is a hot-minded and of vicious character  
and often assaults me without any condition. I under-  
stood that my mother-in-law and two brother-in-laws  
supported her for her criminal and vicious activities.  
Yesterday 25.07.2023, at about 7 P.M., she suddenly  
started to scream and shout at me by saying that  
she want money for buying cough-syrup and she want  
to go hospital, when I told her that I wanted to take  
her to hospital she became furious and started to assault  
me with fist and blows and started to mess-up everything  
in our room, she even ranged her mother and told them  
to come and take her home. I tried to control her but  
couldnt. After few minutes DRADHA RANI KHATRIA, w/o. Dulal  
Khatria @ BISWAJIT KHATRIA, @ INDRANIL KHATRIA, both are sons  
of Dulal Khatria, and three other hooligans came my house  
and pulled me out of my house in front of my family  
members and assaulted me brutally with my persons  
with iron rod and attempted to kill me. Thereafter I was  
anyhow rescued by the help of family members and nearby  
people. It is pertinent to mention that the above miscreants  
are my In-laws, they took my wife and went away. While  
leaving they threatened that they will kill me within  
short time.
