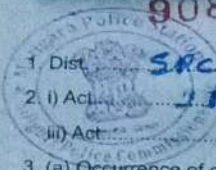

**Sub:- Complaint letter against threatening, heating & molestation.**

Respected Sir,

I am Smt. Sanchayita Banerjee Sarkar (M.Sc. & Ph.D. Fellow., W/o. Sri Debabrata Banerjee, Proprietor of DECORA & Himalay Marble, Situated at Near TCP More, Khaprail Road, P.S. – Matigara, Siliguri, 734010. Since 2019).

On 30/06/2023 I dismissed my contractual Staff Bikash Biswakarma, S/o. Sri Ramprakash Biswakarma, Aadhar 6669 5434 8412, Vill- Nema, Matigara, Siliguri, W.B., 734009, India. Mobile – 89676 23411, for various issues. Same day about 9:30PM he called my husband & threaten him. My Husband understand that he is fully drunk so he told him please come tomorrow at 10AM in my office & returned all company's advance loan, products like Bajaj Pulsar 125, Samsung Android Mobile, etc.. But Same Day about 10:00PM he came to my present rented residence Flat ( 2<sup>nd</sup> Floor, Govt. Colony, PO & PS - Matigara , Owner Sri Amit Ghosh) my husband welcome him that time his sister in-laws husband and his nephew came home. When he enter the room suddenly he taken my official Mobile Samsung A7 thrown on the floor and phone was broken. He aggressively used slang languages to us, repeatedly I requested to him to stop this behaviour, but he didn't listen me. Suddenly he attacked my husband and hitting and torn my husband shirt. That time our apartment neighbours came and rescue us from him ( Bikash Biswakarma). He taken our bike and when I told him to return the bike he dined to given us. That time we decided that going to Matigara police station and complain against him ( Bikash Biswakarma), suddenly (approx. 10:30PM) some people come to our door and start hitting me & my husband continuously & vigorously with some very bad slang languages. That time we don't know them and their name also and also we didn't understand that why they attacked us? May be Bikash Biswakarma fitted them! After that we know some people names i.e. Pappu Ghosh and his entire family, Pradip Ghos and his 2 sons one Baptu and other family members and Rupchand Ghosh and his family. We were tried to enter our house but they did not enter the house and torn my kurti and try to molest me and hit my head on the wall and said very bad slang languages. We repeatedly say sorry and asked why they were attacked us but they didn't listen anything. This all incident were happened in front of our 11 years old daughter, and she was crying for rescue us, she also requested them please left us but they were not heard my daughter. She called 100dial for several time, but didn't get any answer. We were very injured, scared and puzzled why they were doing these mishaps with us, what is our guilty? In this situation our apartment neighbours again rescue us from them (approx. 10:50PM). They (above mentioned peoples) were continuously hitting us. When we were rescued & entire our house, we were repeatedly call 100 dials & Matigara Police Station 03532511210 Time 11:30PM but not response. So,

we were sending an e-mail to Commissioner Sir for rescue & security on 11:15 PM. Mr. Tanmay Kundu Sir came to our flat about 11:45 PM with the flat owner Mr. Amit Ghosh, His Wife Mrs Debolina Bhattacharya Ghosh & some local peoples and asked what happened to us? We told him the whole incident. After hearing the incidence and they goes back and our house owner verbally order to vacant the flat immediately. After that when we decided going to the Matigara police station but we didn't come out from our house because thoes ( Pappu Ghosh and his entire family, Pradip Ghos and his 2 sons one Baptu and other family members and Rupchand Ghosh and his family) peoples were sitting in front of our door and continuously threaten us and said if we came out on road then they again do same. So, we didn't come out and spend whole night sleepless and scared. Next morning (01.07.2023) we went to Hospital with very scary for medical, but Dr. told us to come after 2 PM because we were very injured and need to check properly. After that we went to Matigara police station for submitting a complaint against them. Duty Officer taken my complaint but, didn't gave me the received copy, he told us that 1<sup>st</sup> they will do enquiry after that they will give us the received copy. I am a working woman so every day I am going for work at 8 AM & returned at 6 PM, My Husband going to work 8 AM & returned 9 PM, My Daughter going to school 8 AM & returned 3:30 PM. My Husband working nearest to you so he is regularly visited to your Police Station. On 08/07/2023 evening we went to Matigara Police Station and asked an one Lady Police officer about our complaint and madam told us that Panchayat election 2023 so lots of officers not available you come after Panchyat election. On 17/07/2023 my husband & my elder brother went to Matigara Police Station about 5 PM presnt Duty Officers ask them who was the duty officer that day(01/07/2023)?, My husband told him that he didn't know the duty officer name (01/07/2023) then duty officer told them to come after 8 PM because that time all officer are available. As per Duty officer word my husband & brother went to the police station on 8:30 PM & asking to the same Duty Officer he said you are contact with 2<sup>nd</sup> Officer. When husband & brother meet with 2<sup>nd</sup> officer he was listen carefully my husband that what happened with us? Then they (my husband and my brother) were describing all the incidence to 2<sup>nd</sup> officer. After that 2<sup>nd</sup> officer ordered to his PA for searching the complaint letter status. After some time, PA inform to 2<sup>nd</sup> officer that the complaint letter is not found at Matigara Police Station & case is also not registered. 2<sup>nd</sup> Officer told them (my husband and brother) to submitted again a complaint on behalf of that date.

Sir why my complained letter was lost? Why no investigation is there? Why Case is not registered? In your Police Station?

It is a humble request to you please accept my complaint and please take a quick action in this incidence that why they were attacked us and why they were try to molest me? I attached me & My Husband medical reports, Commissioner mail copy, screen shot of 100dial.

This is for your kind information and necessary action.
