Sir,

In producing herewith One (01) arrested accused person namey Manoj Chettri (32 yrs) S/O Dil Bahadur Chettri of Rangpo Bazaar, Sai Line, PO-Rangpo PS-Kalimpong, Dist- Kalimpong (Not Verified) along with the following articles under seizure viz:

- (1) Fifty One (51) grams of said to be Brown Sugar wrapped in a black colour polythene which was found inside a black colour sunglass case and Marked as exhibit-"A"
- (2) One (01) Black Colour Sunglass case Marked as exhibit-"B"
- (3) One (01) VIVO android Mobile Phone bearing IMEI No 868501058993971 containing SIM No 7364866397 in working condition Marked as exhibit-"C"
- (4) INR Rupees One Thousand Eight Hundred Only (Rs 1800/-) in denomination of (i) RS 500/- x 2 = 1000/- (ii) Rs 100/- x 8 = 800/- Total Rs 1800/-

I, SI Sailesh Subba of Matigara Police Station, Siliguri Police Commissionerate, do hereby lodge this written complaint against above noted accused person namey Manoj Chettri (32 yrs) S/O Dil Bahadur Chettri of Rangpo Bazaar, PO-Rangpo PS-Kalimpong, Dist- Kalimpong to the effect that on 27.07.2023 at about 22.15 hours, a source information was received that one person possessing huge quantity of contraband substances illegally is coming out from Biswas Colony and If acted quickly he may be apprehended along with contraband substances. Accordingly, the matter was diarized vide Matigara PS GDE No. 1419, Dated 27.07.2023 and informed the matter to the Officer-in-charge of Matigara PS/SPC in writing and as per his kind instruction, myself along with SI Sajal Roy, SI Agen Lepcha, SI Goutam Mallick, ASI Abdul Latif, ASI Pema Dorjee Sherpa, C/974 Mintu Sen and CV/ 643 Animesh Roy all of Matigara PS, Siliguri Police Commissionerate, left for Matigara Bypass More under PS- Matigara, Dist- Darjeeling by Govt. vehicle vide Matigara PS GDE NO 1420 dated 27.07.2023 and MCC No 303/23 dated 27.07.2023 to verify the veracity of the information.

At the time of departure from office I took envelope, white paper, sealing wax, gum, seal, digital weighing machine (Certified by the weight and Metallurgy department) and other investigation kits as it would be needed if any contraband substance will be recovered.

At around 22:30 hrs we arrived at Matigara Bypass More and called two independent witnesses namey (1) Shri Mahesh Gupta S/O Ramchandra Gupta of Khaplashi, Sainikpuri Road, Khaprail, PO- New Chamta, PS- Matigara, Dist- Darjeeling (2) Prakash Ghosh S/O Motilal Ghosh of Beldangi, Tumba Jote, PS- Matigara, Dist- Darjeeling and disclosed our identities to them and shared our information in hand and requested them to accompany us and remain present as witnesses during the process of whole search and seizure if necessary. I, also requested videographer namey Somnath Chatterjee S/O Sushil Chatterjee of Aurobindo Nagar, Ward No 22, PS Siliguri, over his mobile phone to come at Matigara Bypass More with his video camera and requested him to record the entire process of search and seizure.

Thereafter we parked our vehicle at a considerable distance and noticed that one person was coming from Biswas Colony by crossing Rail line towards Matigara Bypass More and being shown and identified by my source we managed to apprehend the said person who was carrying one black color sunglass case in his right hand. We disclosed our identity as a Police person of Matigara PS to the detained person.

On being asked, the detained person disclosed his identity as Manoj Chettri (32 yrs) S/O Dil Bahadur Chettri of Rangpo Bazaar, PO-Rangpo PS-Kalimpong, Dist- Kalimpong. I informed him that we had a specific information that he had in his possession huge quantity of "narcotic substance". Initially he denied having any "Narcotic substance" in his possession, but I told him that we would search his person and the sunglass case which he was carrying. Finally he disclosed that there is approx 50 (fifty) grams of brown sugar inside the sunglass case. On being asked he stated that he did not have any license to carry Brown sugar. It was clear that he has illegally procured and transporting the "Narcotic Substance" without any valid documents.

Thereafter, I served him a Notice giving him option of "whether he wanted to be searched in presence of Executive Magistrate or by any Gazette Officer". To this, he agreed to be searched by any one of them. I also offered the independent witnesses accompanying us, and the accused person to search our Police Party as per provision, but they denied to search the police party.

I then sent ASI Pema Dorjee Sherpa with a requisition to Special Executive Magistrate, Shri Suraj Thakuri, ACP, East-II, SPC requesting him to come to the spot for supervising the process of search and seizure.

At around 23:20 hours, ASI Pema Dorjee Sherpa returned at the spot along with Special Executive Magistrate, Shri Suraj Thakuri, ACP, East-II, SPC and he disclosed his identity as Special Executive Magistrate, for the day to the detained person as well as the independent witnesses told them that he would be supervising the process of search and seizure. As instructed by Ld. Special Executive Magistrate and under his supervision in presence of two independent public witnesses, search was conducted of the detained person Manoj Chettri, observing all formalities and recovered one Vivo Mobile Phone and Rs 1800/- from right pocket of his trousers and others nothing could be recovered from his person except his wearing apparels. Then the sunglass which was in his right hand was searched and then found above noted seized contraband articles inside the sunglass case.

On being asked about the valid documents the apprehended person was unable to produce any document/license in support of that "Narcotic Substance" that was in his possession, He confessed that he was carrying this business illegally. He used to procure it from Biswas Colony and used to sell it to his customers for his wrongful gain.

As instructed by Shri Suraj Thakuri, ACP, East-II, SPC, Special Executive Magistrate, I seized all above noted articles under proper seizure list in presence of the above noted independent witnesses and took the signatures of the witnesses and the accused person on the seizure list. I then labeled and sealed the "Exhibit-A", Exhibit-B" and "Exhibit-C" in presence of the Special Executive Magistrate, independent witnesses and the accused person. The seizure was made in between 23.25 hr to 23:55 hrs. Dated: 27.07.2023. The whole process of search and seizure was videographed by the videographer.

The apprehended accused person namely Manoj Chettri (32 yrs) S/O Dil Bahadur Chettri of Rangpo Bazaar, PO-Rangpo, PS-Kalimpong, Dist- Kalimpong confessed before the Special Executive Magistrate and other witnesses that he used to procure "Narcotic Substance" clandestinely from Biswas Colony for the purpose of selling the same to his designed customers for his wrongful gain by illegal means and that he was doing this for a long time.

I then arrested the apprehended accused person namely Manoj Chettri (32 yrs) S/O Dil Bahadur Chettri of Rangpo Bazaar, Sai Line, PO-Rangpo PS-Kalimpong, Dist- Kalimpong (Not Verified) under proper Memo of Arrest for violating the terms and condition of the NDPS Act, after observing all guidelines of Apex Court. His ground of arrest was duly communicated to him.

Under the above circumstances, I pray before you that a specific case under proper section of law may kindly be started against the accused person named Manoj Chettri (32 yrs) S/O Dil Bahadur Chettri of Rangpo Bazaar, Sai Line, PO-Rangpo PS-Kalimpong, Dist- Kalimpong (Not Verified) and arrange for its investigation.
