Sub: FIR regarding fierce fight/brawl at a Bar in Citi Centre on the 26th July, 2023

Sir,

H. Kanta Raj Singh
I, Sunita Gazmer, mother of Prashant Singh, resident of Balajee Apartment, Nivedita Road By-lane, P.O & P.S Pradhan Nagar, Siliguri would like to draw your kind attention towards the subject as mentioned above. Hope you will treat the same as FIR and take firm action against the accused as early as possible.

In fact, my son Prashant Singh along with four or five of his friends viz. Sunny Lama, Nimesh Gurung, Jiwan Limbu, Pappu lama and Abhijit Chaudhary had visited a Beer Bar "BEER REPUBLIC" Citi Centre, Matigara- Siliguri for a small get together in the morning of 26th July at about 2:30 AM. They were having soft drinks and were dancing in order to enjoy their re-union after a long interval of time. Since they were dancing barefoot on the dias some unknown person who was also dancing on the same floor suddenly started having a heated discussion with one of my son's friend. The opponent party also were in a group of six or seven members. After a heated discussion of about half an hour on the venue of dancing on a minor issue the matter has been settled and calmed down. As per Mr. Sunny Lama's version, my son's friend who was also present on the venue, the opponent group started leaving the Beer Bar one after another with the threat to see them on the basement parking of the Citi Centre.

Once my son Prashant Singh along with his friends came down on the basement of the Citi Centre to leave for their respective homes the opponent group suddenly attacked them leaving my son severely injured. They have called the

additional hooligans and rowdies and made a group of nearly 20 to 25 members. They attacked with iron rods and empty beer bottles. Prashant Singh, my son has a severe and multiple injuries on his head, his stomach is pierced with an iron rod resulting into pancreas and stomach damage. He is now admitted at Neotia Getwel in the MICU- bed no. 230, under Dr. Pranay Gaurav.

One Mr Alam and the other tallest bouncer of the same bar also helped the opponent group of my son in the entire brawl.

My son is in a critical stage. This is, one way or the other an Attempt to Murder.

The Basement Parking of Citi Centre surely has a CC Camera and I am sure, the footage of the same will help you in the investigation.

Hence you are requested to investigate the matter thoroughly and initiate firm action against the culprit immediately without any further delay.
