

Sir/ Madam,

I Smt. Manisha Chhetri w/o Biru Chhetri, permanent resident of Naya Busty, Karaibari, Milan More Champasari, P.O. & P.S. Pradhan Nagar would like to state a complaint against my husband namely Biru Chhetri, and a lady named Pemu Sherpa, D/o Phurba Sherpa, who is presently residing at Building No. 5 at Luxmi Township, under P.S. Matigara.

That we had a child born out our wedlock namely Swaiksha Chhetri and I have been living in our in-law's house supporting my child and myself and also dealing with mental torture from my husband and Pemu sherpa. That my husband and Pemu Sherpa has been living together since February 2022, and both of them has been mentally harassing and torturing me day after day and after using foul language and threatening me that he will take all the jewelleryes and money which I had bought during my marriage, he left his house since and did not come till now and from that time I have been in a mental trauma and in the verge of having depression. That my husband after leaving the house has not seen or visited me since and comes home to meet only his parents once in a month and there is no contact with me or my daughter.

That till now he has not given any maintenance for me and my daughter and for that reason I have been residing at my in- laws house till now as his (Biru Chhetri) elder brother and his wife has been supporting me and my daughter. That in the month of August 2022 my husband suddenly pressurized me for divorce but I refused as I have a minor daughter and from that time, we have no contact with each other.

That I pray to the concerned authority to take appropriate steps and take action immediately in any way possible and inquire into the matter for the ends of justice.
