Respected Sir,

I, **Smt. Asha Gharami (Bhuia)**, W/O, Sri. Manoj Bhuia, D/O, Late rabi Gharami, aged about 24 years, Hindu by religion, housewife by occupation, resident of Rangapani, P.O:- Ranidanga, P.S:- Phansidewa, District:- Darjeeling, Pin: 734012, beg to report you the following facts:-

1. That I am submitting this FIR against my own elder Sister namely Smt. Pramila Das and her husband namely Ashis Das, S/O, Sri. Sanjoy Das, at present resident of Shantimoy Colony, Patiram Jote, P.O & P.S:- Matigara, District:- Darjeeling and permanent address at Jibdhar Pur, P.O:- Chakdhay, P.S:- Suri, Dist:- Birbhum for the offences committed by them as stated below:
2. That Since after my said alleged elder sister marriage, they (said elder sister and his husband) were living/ residing at my Paternal house at Shantimoy Colony, Patiram Jote, P.O & P.S:- Matigara, District:- Darjeeling. After coming to my Parental house as casual visit to see my old aged widow mother, I found that my elder Sister and her said alleged husband was used to abuse my said old aged widow mother in front of me, while I was protested then they also used to abusive and vulgar words to me, rather than said alleged husband of my elder sister casted lustful, sensual and sexual evil look and eye upon me.

Several times he gave me sexual offer and tried to molest me but any how I saved myself from his such action. As I did not agree to his such sexual offer and as I told him that I would disclose his such acts and activities to all, so, he continuously tortured me both physically and mentally.

3. That on previous day, i.e., on 27/07/23, at about 5 p.m (at evening) I went to my Paternal House and suddenly, my said allege sister had started to physical assault upon me and allege sister's husband ,Ashis Das attempted to molest me but when he failed to do so on my strong resistance, then he abused me by filthy languages and physically assaulted me by fists and blows and opened my wearing apparel cloths and touched different sensitive parts of my body and in this way, ultimately, he outraged my modesty. Moreover, he snatched gold neck chain weighing 1 (one) bhori from my neck. Thereafter, I raised hue and cry. Seeing some persons coming at the spot and saved me from their clutches. Therefore, I have received/ sustained injuries and suffered bodily pain on my respective body persons.
4. That it is mentioned here that said Ashis Das had/has lustful, Sensual and sexual look and eye upon me. Several times he explicated sexual overture to me and demand for sexual favours and made sexually coloured remarks towards and upon and to me. He used to watch my privacy and always followed me for his sexual favour and interest while I was in my Parental house (details as stated above), but each and every time, I denied to do so.
5. That sir, I am passing my present days in immense fear and stigma due to aforesaid conduct of said Ashis Das and Pramila Das.

PRAYER

I, therefore pray, before you to kindly take necessary steps against the aforesaid two culprits by registering a Specific Case against them for administration of justice.
