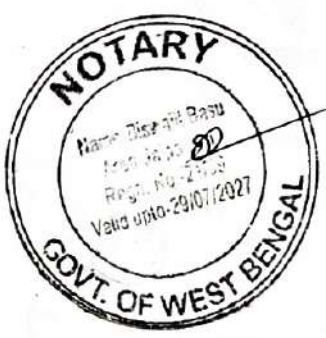

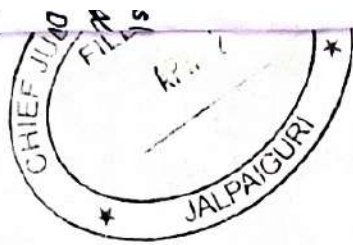
The Complainant above named begs to submit as follows :-

1. That there is an electric connection vide Consumer ID No.400925998 in the godown of the Complainant situated at Kanchanjungha Complex, within Ward No.42 of Siliguri Municipal Corporation at Salugara, Sevoke Road, Siliguri.

2. That since the year 2014, the Complainant has been enjoying electricity in its said godown through an electric Meter being No.BB1101625N, but suddenly in the month of July 2022, the said meter was found stolen by the miscreants. Immediately a complaint was lodged to the Inspector In-charge, Bhaktinagar Police Station vide Bhaktinagar P.S. G.D.Entry No.613 dated 12.07.2022.

3. That thereafter the said incident was also informed by the Complainant to the Station Manager, W.B.S.E.D.C.L., Power House, Siliguri and applied before him for new electric meter and ultimately a new meter was installed in the said godown of the Complainant on 10.11.2022.

4. That on 09.01.2023, it was found that the said new meter had again been stolen by the miscreants and immediately the said incident was informed to the Station Manager, W.B.S.E.D.C.L., Power House, Siliguri.

5. That in the meantime, on enquiry, it is learnt by the Complainant that the Accused person and his associates, illegally entering and/or trespassing into the said premises, had stolen both the aforesaid electric meters, so that the Complainant cannot enjoy the electricity in its said godown.

6. That immediately the Complainant on 19.01.2023 lodged a complaint against the Accused person and his associates to the Inspector In-charge, Bhaktinagar Police Station.

7. That though the said complaint disclosed a specific case of house trespass and theft, but the Inspector In-charge, Bhaktinagar Police Station, without starting any case upon the said complaint, made a G.D.Entry being No.866 dated 19.01.2023,

8. That as the Inspector In-charge, Bhaktinagar Police Station avoided to start any case upon the said complaint, the Complainant on 04.04.2023 wrote a letter, enclosing the said complaint, to the Commissioner of Police, Siliguri Police Commissionerate, requesting him to take necessary action upon the same.

9. That in spite of receipt of the said letter by the Commissioner of Police, Siliguri Police Commissionerate, no case has yet been started upon the said complaint.
