Out of the lawful wedlock, a son was born in the year 2003, namely Master Raunak Sharma aged around 19 years. Due to regular physical and mental harassment from my husband and his relatives I returned back to my parents house in the year 2008.

After a year, I got remarried to my brother-in-law Sri Rakesh Sharma, Son of Late Kishan Lal Sharma, on 4th April 2009, at Siliguri. Out of this wedlock, I have one son namely Master Viom Sharma, born in the year 2016. After my marriage I came across the fact that my husband Sri Rakesh Sharma has multiple engagements with various girls and has involved himself into other matrimonial commitments also. He has been torturing me since the day of the marriage but lately he has involved in his torture my family members including my mother, brothers, sons, sister-in-law. His torture has been life threatening and endangering to both me and my son. Yesterday he had entered my mother's house and fought and hit with all my relatives there and alleged me of having stolen his gold from his house.

I thus request you to look into the matter and provide me with necessary assistance.
