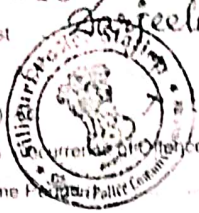

Subject- Written Complaint against Rabindra Yadav.

Sir,

I, Smt. Manu Krishna, wife of Sri Kunal Kumar, Editor in chief Siliguri Express, having office situated at Singh Mansion, 4<sup>th</sup> Floor, Punjabi Para, P.S. Siliguri, Dist. Darjeeling want to lodge a written complaint to the effect that one Rabindra Yadav, s/o not known, resident of Ganga Nagar, Siliguri, P.O. & P.S. Siliguri, Dist. Darjeeling who was employed/engaged to my news channel namely Siliguri Express as cameraman and as such he was provided with a ID Card of Siliguri Express, office keys, mobile phone for official purpose.

That the said accused Rabindra Yadav was continuously on leave since last few days on various pretext but suddenly on 29/07/2023 at around 8.30 P.M. without any information had entered into my office situated at Singh Mansion, 4<sup>th</sup> Floor, Punjabi Para and thereafter he had stolen my hard cash amounting to Rs. 50,000/- (Rupees Fifty Thousand only) which were kept in the drawer of my office along with all the hard copies of important documents and not only this he had also damaged the router & internet connectivity of my office and had also stolen my software data and thereafter had erased all my software data with ill-motive.

That subsequently on 30/07/2023 at around 12.12 A.M. Rabindra Yadav informed me through WhatsApp Messenger that he won't continue his work with Siliguri Express and as such he resigns from the office of Siliguri Express.

That today morning when I entered into my office I was shocked and surprised to see the condition of my office as done by Rabindra Yadav.

That Rabindra Yadav has not only committed theft here but he had also committed criminal breach of trust as he was entrusted with the office keys and other office materials.

Therefore, it is humbly requested to you to kindly look into this matter and thereafter to take stringent action against the said the said accused Rabindra Yadav as per the relevant laws of the land.
