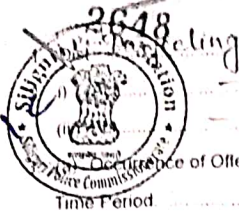

Sub:- Written complaint against 01(one) TOTO Driver of plying illegally on Sevoke Road without any valid documents causing obstruction to public way.

Sir,


I SI, Kamal Kr.Roy of Panitanki Traffic Guard, SPC beg to lodge a written complaint that on 31.07.23 around 17.45 hrs, while on duty at Sevoke Road area found one (1)TOTO without any registration number stationed near Panitanki More in such a way blocking the free flow of traffic and causing hindrance and danger to the general public and other vehicles.

Accordingly I detained said TOTO and on being asked the driver disclosed his identity as Gobinda Paul (35 Yrs), S/o- LT.Mani Paul of Bari Vasa Bashbari P.S- Bhaktinagar Dist- Jalpaiguri. Further on being asked to produce relevant documents in support of his claim of plying TOTO on Major Road he failed to produce any valid documents. Thereafter I seized the TOTO and arrested the person under section 41 Cr. PC in c/w the case after observing all rules and formalities.


Therefore I would request you to kindly start a specific case against the above noted person (TOTO Driver) under proper section of law from your end.
