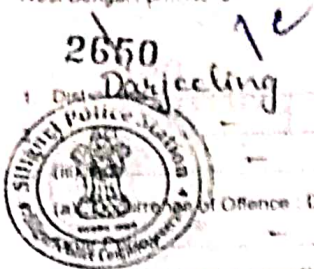

**LOGGING FIR AGAINST ENCROACHMENT AND ILLEGAL CONSTRUCTION IN
A-1 DEFENCE LAND, ADJACENT TO DEFENCE ACCOUNTS OFFICE,
SEVOKE ROAD SILIGURI**

1. It is submitted that on finalisation of joint survey report conducted with Defence Estate Office, Siliguri, Land Record Office, Siliguri Municipal Corporation and Station Headquarters Siliguri it was verified & confirmed that Army is in possession of 0.61 Acres A-1 Defence Land, adjacent to Defence Accts Office, Sevoke Road Siliguri.

2. On confirmation of boundary it was found on 14 Mar 2023 that three illegal temporary shops made of iron sheets have been constructed by the following persons within the defence land without any agreement or permission of Army :-

- (a) Mr Laltu Midya s/o Pulin Midya, Calcutta Flower Shop.
- (b) Mr Bappa Ghosh s/o Ramchandra Ghosh, Ghosh Flower Shop.
- (c) Mr Dinesh Das, owner of Store shed.

3. All above three tenant shopkeepers have been given show cause notice three times both in Roman Hindi and local Bangla on 15 Jun, 30 Jun and 15 Jul 2023 (Receipted copies att at Appx 'A'). In reply, to these eviction show cause notices to tenants two shop owners Shri Sanjay Agarwal and Smt Anima Mondal have attempted to justify their illegal occupation (copy att at Appx 'B' & 'C') without any Land Holding details or Revenue Records. An inquiry report has also been sought by DM Darjeeling from SDO Siliguri and Commissioner Police Siliguri vide his Memo No 183/I-08 Part III/2023/JM dated 04 Jul 2023 (Copy attached at Appx 'D').

4. It is now requested that FIR be lodged against the above three shop keepers and necessary action be taken to evict them, being illegal encroachers on defence land and dismantle the unauthorised temporary shops for continued utilisation of Defence Land by Army.
