I, SMT LAKSHMI SHARMA W/o Sri Nirmal Sharma, Hindu by religion, Indian by Nationality, Press Reporter by Profession, resident of Bipul More, Near Binay More, Pipeline, Dabgram-2, Middle Shantinagar.

Would like to inform you following facts:-

1. That on 30-07-2023, I went to cover a program of Chakravayu Natak in Dinabandhu Manch. While I was busy in my work of covering the program, I was intervened by a lady named Nisha Gupta w/o Arun Gupta R/o Punjabi Para, Siliguri. Mobile number (9832631005 & 9641000005).
2. That the lady was trying to talk to me but the behavior and the language of the lady was very rude so initially, I avoided to engage with her verbally and continued to do my work.
3. That to my surprise the lady started using abusive language with me and defaming my image in the crowd. For no reason she started pushing me and provoking me to say or do something wrong.
4. That when she was not successfully in provoking me she started threatening me that she will get me killed. That the lady's behavior was very bad and rude she has also threatened me that she and her husband will go to my house and kill me.
5. That I being a press reporter has to visit various places for my work and I am very terrified and don't want to face these kind of situation.

In such circumstances finding no other alternative I come to you with this written complaint and request you to take necessary legal against the culprits.
