M. P I, Swarnava Roy, son of Sushil Roy, resident of Pankaj Roy Sarani, Deshbandhu Para, Wardnissionerate No 30 under S. M. C., P. O. & P. S Siliguri, Dist. Darjeeling, would like to inform you that as follows:-1) That I have a business named "ROY TRADERS" dealing with bakery & ice-cream raw materials. 2) That one KARTICK GOEL, son of Ramesh Goel, resident of Panchai Sundar Apartment, 2nd building, Champasari Kali Mandir road, ward no 46 under S. M. C. P. O. & P. S. Pradhan Nagar, Dist Darjeeling is one of my permanent customer/client since the year 2019. On 11.04.2022 he purchased bakery raw materials from me worth rupees 2,63,051/- and out of which he paid rupees 1,56,315/- in total partly both through bank and cash keeping Rs 1,06,736/- as due. Thereafter from 01.07.2022 till 09.07.2022 he again purchased bakery raw materials worth Rs 3,03,016/-. He acknowledged and promised that he would pay the total outstanding dues 4,09,752/- within one month i.e. 09.08.2022. 3) That in the month August, 2022 he had issued me three cheques of Union Bank of India

- 3) That in the month August, 2022 he had issued me three cheques of Union Bank of India for Rs 1,13,000/- each in my favour and promised that he will pay the rest outstanding amount Rs 70,752 in cash later. When I tried to encash those cheques all of them did bounced due to insufficient fund. Then in the month of September I have served a legal notice through an advocate and where I stipulated 15 days within which he had to pay all my outstanding an advocate and where I stipulated 15 days within which he had to pay all my outstanding an advocate and kartick Goel approached and coerced me to enter into a mutual agreement due. Again said Kartick Goel approached and coerced me to enter into a mutual agreement with him where he declared that he shall provide me three more cheques for Rs 1,29,876/- with him where he declared that he shall provide me three more cheques for Rs 1,29,876/- with a mutual agreement on 1st September,2022 upon aforesaid terms and on the same day into a mutual agreement on 1st September,2022 upon aforesaid terms and on the same day one cheque of Union Bank of India, cheque no. 195784 Rs 1,50,000/- which was encashed/liquidated successful, but other two cheques of U. B. I. on 02.11.2022 and encashed/liquidated successful, but other two cheques of U. B. I. on 02.11.2022 and 26.11.2022 for Rs 1,29,876/- each did bounced due to insufficient funds. I understood that said Kartick Goel is cheater and thus cheated me. I came to know from reliable sources that he had cheated many people by using above kind of tactics.
 - 4) That I and my father Sushil Roy visited his factory several times but he and his emissaries gave us fake promises that he would refund as our outstanding dues Rs 2,59,572/- but in vain. Till today I requested him incessantly to pay his outstanding dues and even confessed that I have suffering irreparable losses but he turned his deaf ear to it.
 - 5) That on 30.07.2023 at about 9.30 am I along with my business colleagues, those who also cheated by him went his factory first, but he was not there. Then we have to go his residential to visit him. When we met I asked him to kindly pay his outstanding dues to us. Then suddenly he became furious and called his wife, both of them started hurl abuses to us and said that he will not clear the outstanding debts. His wife also threatened us that "Do whatever you want to do, I do not fear any police. I am a advocate and I will lodge a false F. I. R against us.

I therefore, request you to kindly take necessary legal steps against the said Kartick Goel and put him behind bars as soon as possible. I shall be highly obliged to you forever.
