Respected Sir,

With due respect and humble submission I, Ayesha Thapa Daughter of Sri Amrit Thapa resident of Matigara Bazar, Post Office and Police Station Matigara District Darjeeling would like to inform you that yesterday there was a programme of Mantra Band in Error and I was there with my sister and at around 12 a.m. when my sister did not feel well and started vomiting in the VIP lounge then I took her to the wash room and at that time there was a big queue and after waiting a while I got a chance to use one washroom and I sent my sister inside that when she was not feeling well she asked me a tissue paper and when I was about to pass the tissue paper one girl in blue dress barged inside forcefully to use the same washroom so in that I stopped her as she was totally drunk. She abused me but I avoided the scene and I came where I was sitting and started stating how she misbehaved with me inside the washroom. Suddenly I felt that few girls came and attacked me by pulling my hair and literally making me pulling from the floor, they hit me with punches and also attacked me with their nails and also kicked me in my chest and stomach and when bouncer came to save me they started fighting with the bouncers in which they also got hurt but I swear that neither I nor any of my friends have attacked her as there is full CCTV coverage from which things will be clear. In that shuffle also I have lost my gold chain which I think that one the girls have snatched in that fight. After a while when the bouncers took them out to settle the matter we waited for a while to leave for hospital since I was injured at that time when I just tried to go out those girls were assembled with other girls and boys and started attacking me for which one Priyanka also got hurt and I again got scared and took the rescue by going inside the club.

After an hour or half when I could not go towards my home as they had called groups and were waiting us in parking lot then I requested the bouncers to leave me till outside as I was very scared so like 10 bouncers have escorted me till the Sevoke road where my friends came and took me to home and till today I have having a terrible headache as I am suffering from scalp problem and due to that attack I am

not at all feeling well and feel like I have suffered some head injury. Today when one of my friends Parmesh wanted to call and compromise the matter as he said me that its among the girls they talked with him so rudely and abused him with mother and sister slangs and also threatened him that if he interferes they will file a false complaint and make him pay. Therefore Sir, kindly file a case against these illegal and anti social elements as we are not safe they just pick up the fight and it is not safe for us to go anywhere. They just assemble with other boys and have in the intention to harass, fight and snatch things from us. Kindly take this FIR as important and take action against these person immediately and as soon as possible. Thanking You.
