Sir,

In producing herewith two arrested accused person namely Subal Das (25) s/o Jaydev Das of Rananagar, PS Matigara, Dist. Darjeeling and Santosh Roy (32) s/o Lt. Bhagirathi Roy of Rananagar, PS Matigara, Dist. Darjeeling along with one seized vehicle bearing no- WB 85 4971 (Truck) under proper seizure.

I, SI Abhishek Theengh of Pradhan Nagar Police Station, Siliguri Police Commissionerate do hereby lodge this complaint against two accd. persons namely Subal Das (25) s/o Jaydev Das of Rananagar, PS Matigara, Dist. Darjeeling and Santosh Roy (32) s/o Lt. Bhagirathi Roy of Rananagar, PS Matigara, Dist. Darjeeling along with one truck bearing no- WB 85 4971 (Truck) to the effect that today on 01.08.2023 at 00.25 hrs received a specific source information that one vehicle bearing no- WB 85 4971 (Truck) was coming from Baghajatin Colony under Pradhan Nagar PS, SPC under Pradhan Nagar PS, with loaded river bed materials.

Accordingly, I informed the matter to the I/C PS and being directed by the I/C PS I along with assisting force left PS to verify the veracity of source information. On the way towards Baghajatin colony I detained the said Truck bearing no- WB 85 4971 (Truck) with loaded river bed materials at Baghajatin Colony and also apprehended the driver and the helper of the said vehicle who on being asked disclosed their identity as Subal Das (25) s/o Jaydev Das of Rananagar, PS Matigara, Dist. Darjeeling and Santosh Roy (32) s/o Lt. Bhagirathi Roy of Rananagar, PS Matigara, Dist. Darjeeling and admitted their guilt of carrying the river bed materials from Balasan ghat, Matigara illegally for their wrongful gain.

Accordingly, I seized the vehicle bearing no- WB 85 4971 (Truck), loaded with river bed materials and subsequently arrested the driver and helper namely Subal Das (25) s/o Jaydev Das of Rananagar, PS Matigara, Dist. Darjeeling and Santosh Roy (32) s/o Lt. Bhagirathi Roy of Rananagar, PS Matigara, Dist. Darjeeling. The whole process of seizure and arrest was made in between 01:20 hrs to 01:35 hrs.

Hence, I pray that a specific case may kindly be started against the Subal Das (25) s/o Jaydev Das of Rananagar, PS Matigara, Dist. Darjeeling and Santosh Roy (32) s/o Lt. Bhagirathi Roy of Rananagar, PS Matigara, Dist. Darjeeling under proper section of Law and arrange for its investigation.
