I, ASI Chandra Mohan Barman, of Bagdogra Traffic Guard, SPC, presently conducting the Traffic Regulation duty at Bihar more under Bagdogra Traffic Guard, beg to lodge a written complaint that on 22.07.23 around 12:40 pm 01(one) toto vehicle without any registered number is coming from Bagdogra Airport side carrying more than 06 passengers, on the Bihar More new fly over Road, near Bihar More Traffic place the said heavy loaded passenger toto plying wrongly here and there on Bihar more new fly over road and making huge traffic & also disturbance the free flow of traffic. According to an eye witness the Bihar more Bound said toto was running at high speed, over loading with passenger, plying the toto on wrong Lane.

According I ASI Chandra Mohan Barman of Bagdogra Traffic Guard, along with CV 739 Bikash Nagasia of BDR TG had been present at Bihar More duty post place. After some time disclosed the toto driver name as Md. Rafique Sah, S/o- Md Ajad Sah, Age-24 yrs, Address- SuryaNagar, Bagdogra, Dumriguri, Darjeeling, Pin-734014. Accused toto driver fled away from the Spot.

Accordingly, I seized the toto after preparing proper seizure list in presence of witness. Therefore, I request you kindly take action against the said toto driver as per law.
