that on 19.07.23 at around 12:30 p.m, when I was  
returning home after purchasing gas cylinder, I saw  
Roshni Kherwar w/o - Parshuram Kherwar was fighting  
with my friend Gowri Sarkar w/o - Pradip Sarkar in  
the house of Deepak Pradhan s/o - Binod Pradhan, all  
residents of Kokkata Road, Bhujiapani, P.O. + P.S. - Bagdogra,  
Dist - Darjeeling. I tried to intervene and rescue  
my friend, for which they started beating me  
as well. Then they called a meeting with the help  
of local Panchayat member, Smt. Bulbuli Singh w/o -  
Anil Singh on 20.07.23 at around 07:00 p.m, but  
they informed us about the meeting, still we  
reached there to know what the meeting is  
actually about. As soon as I reached there, Roshni  
Kherwar, w/o - Parshuram Kherwar, Sabita Kherwar, w/o -  
Rajat Kherwar, Sonali Kherwar, w/o - Rakesh Kherwar,  
Tanaki Kherwar, w/o - Parshuram Kherwar, Rakesh Kherwar,  
s/o - Parshuram Kherwar, Jyotsna Roy, w/o - Ganesh Roy,  
Anjali Karmakar, w/o - Manmahato Karmakar, Tannu  
Chowdhury, w/o - Rabinindra Chowdhury, Sunila Pradhan,
