Sir,

In producing here with one arrested accused person namely Pratap Kujur (35) S/o Lt. William Kujur of Bhojnarayan Tea Estate, New Pacca line, Kamala Bagan PS Bagdogra Dist. Darjeeling and seized 01 (one) Tractor having registration No. WB-92-G-7559 loaded with river bed materials as per proper seizure list.

In this regards I ASI Ashok Sarki of Bagdogra PS , SPC lodged a written complaint against the above noted arrested accused person to the effect that on 23/24-07-23 night at 00-05 hrs I alongwith C/875 Shesnath Jha , CV-389 Janak Singha , V-375 Jogesh Barman were performed special night Mobile van duty vide Bagdogra GDE No. 1085 dtd. 24.07.23 and at 04-15 hrs received source information some loaded Tractors were seen with carrying riverbed material unauthorisely at Bhojnarayan Tea Garden area and moving towards Bagdogra side . Accordingly I informed the matter to the O.C. Bagdogra PS and also duty officer of PS and as per direction myself alongwith force with K-36 mobile van reached Bhojnarayan Tea Garden area and found that the above noted Tractor loaded with riverbed materials was coming from Balasan river side at Bhojnarayan Tea Garden area. I alongwith force detained the said Tractor on Bhojnarayan Garden Road near New Health Centre under PS Bagdogra and apprehended the driver of the said Tractor and found that the said Tractor was loaded with riverbed materials. On demand the driver of said Tractor failed to produce any documents/papers in favour of the carried substances (riverbed materials) and also failed to produce papers in support of the said vehicle. During enquiry it could be ascertained that the riverbed materials were loaded from Balasan river illegally. Thus it is suspected that the organized racket in operation for carrying riverbed materials illegally for wrongful gain and thereby causing huge revenue loss to the Government of W.B. As such I seized the above noted Tractor loaded with riverbed materials with proper seizure list and arrested the driver of the said Tractor and he disclosed his name and address noted above. The seizure and arrest was done in between 05-15 hrs to 06-05hrs.

Under the above circumstances I pray that a specific case may kind be started against the arrested person namely Prātap Kujur (35) S/o Lt. William Kujur of Bhojnarayan Tea Estate, New Pacca line, Kamala Bagan PS Bagdogra Dist. Darjeeling and arrange for its investigation .
