Kindly lodged the matter as "FIR" in your custody.


That on 25.07.2023 at about 7 A.M. it has been reported by the garden night chowkidars, namely 1) Sri Bikash Tigga S/O. Sri Pairoo Tigga of Katajhar line and 2) Sri Sohan Nagesia S/O. Late Melha Nagesia of Hatkhola Line that about 90 meter Cable of 3 core flat copper wire in 25 sq.mtr. specification has been stolen from the Deep Tube Well spot in Section No 9A of the Estate. During stolen periods by the miscreants of the cable they have fully damaged- to one capacitor of 25KVVR and a main switch of 250 Amp. which was used for irrigation purposes of the estate.


