With due respect, I Anita Rai, w/o - Basudev Rai, resident of Stalin Nagar, P.O + P.S. - Bagdogra, Dist - Darjeeling want to state that my son Divas Rai s/o - Basudev Rai, aged 20 yrs resident of Stalin Nagar, P.O + P.S. - Bagdogra, Dist - Darjeeling, and his friend Arvind Gungy, s/o - Sombahadur Gungy aged 20 yrs, resident of Stalin Nagar, P.O + P.S. - Bagdogra, Dist - Darjeeling were walking on the road near Shani Mandir Lekha Nagar today dated 25.07.23 at around 07:00 pm. Suddenly a TVS Apache Motorcycle which was ridden by some unknown person hit them furiously from back, which made the two child fall off the road. Due to this accident my son got some injuries in his back, but the other victim is seriously injured and has been referred for better medical treatment by Bagdogra Primary Health Centre.

Both the rider and pillion were fully drunk and they were overspeeding (at around 90 km/hr) while moving towards Bagdogra from Benglubi side, which caused the accident. They were hit on the wrong side of the road.

Hence I would request you to kindly investigate into the matter and take proper legal action against the culprits.
