I, Smt. Sonia Roy Pradhan, Wife of Sri Kiran Pradhan, presently residing at Naya Busty, Panthabari, P.O. & P.S.- Bagdogra, Dist.- Darjeeling, would like to lodged this Complaint against my husband viz. Sri Kiran Pradhan, Son of Late Purna Bahadur Pradhan, resident of Naya Busty, Panthabari Forest, P.O. & P.S.- Bagdogra, Dist.- Darjeeling.

Sir, in the year 2017, one valid Hindu marriage was solemnized in between myself and Sri Kiran Pradhan following the Hindu rites, rituals and customs and the aforesaid marriage is love one.

Sir, after our marriage, the family member have duly accepted our marriage at one social marriage was organize by both the family members of myself and said Sri Kiran Pradhan and at the time of social marriage my family members have given one Bed Set (cot), Dressing Table and furniture and also other Kitchen utensils, as per the demand of my husband, as dowry.

Sir, after completion of marriage, took myself at his house and accordingly, we have a started living there as husband and wife at my matrimonial house. After lapse of some days, I have come to learnt that said Sri Kiran Pradhan (my husband) is a habitual drunker and in intoxication mood said Sri Kiran Pradhan used to return home, at late night to beat me mercilessly with fists and blows, but I have tolerated the said physical and mental tortures without making any complaint with a hope that everything will be alright by lapse of times.

Sir, my husband in fully intoxication mood used to create mental pressure upon me for bringing more cash dowry of a sum of Rs. 40,000/- (Rupees Forty Thousand) from my parents. But I tried to make him understand that my parents have already incurred a huge expenditure on my marriage and my parents are belongs from lower middle class family and thus, it is not possible for my parents for bring more cash dowry, after hearing such without any rhyme and reason my husband started beating me mercilessly with fist
