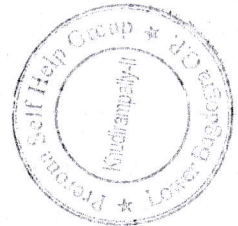

Respected Sir,

I Smt. Pratima Rai, w/o sri Megraj Rai, resident of khudiram pally, Po+Ps Bagdogra, Darjeeling (WB) would like to inform you that I & other nine members is running a self help group which is sponsored by the Govt. of West Bengal, the name of the group is "PRERONA SWARNIRVAR DAL" and we have taken the loan from this group. I have selected the Group Leader for this group. In this group Smt. Puja Sarkar, w/o Sri Swapan Sarkar of khudiram pally, Bagdogra has selected as a post of cashier. In every monthly meeting, she used to take cash from all of us, i.e total 10 persons including her. As she was depositing principal with interest regularly in this above said group cc account being no: 4001201330002524 and sb account being no: 4001201030057456 of Uttarbanga Kshetriya Gramin Bank, Branch-Bagdogra, But from the March 2023, she has not depositing any amount in this group neither principal nor any interest. In the month of July when we updated our group's account after that only we came to know about the facts that she has not been depositing the amount from the month of March 2023, only once interest has deposited in the month of July. When all group members went to her house, at that time her husband told us that she has already fled away from my house with someone. Her husband has also lodged a missing diary at Bagdogra p.s on 02/07/2023. As all of the members of this group are innocent and paid their principal with interest regularly to her for depositing to the bank as per the norms of the group. Now all of us are in big trouble as all of us belong to poor family background and we cannot afford to such huge amount near about 2.5 lakhs which she has not deposited in the bank. Now bank is pressurizing us to clear such a huge amount 2.5 lakhs approx. It is impossible for us to clear or to repay that amount.
